I then made contact with the driver and passenger. The driver was identified as Keith C. Pharo (w/m 11/13/58) and the passenger, Jennifer M. Breen (w/f 01/15/78). At this time Police K-9 Officer James Kaminski and Police K-9 Cole arrived on scene and conducted an exterior sniff of the vehicle. Officer Kaminski informed me that K-9 Cole alerted him to the presence of an unknown narcotic odor.</p> <p>A search of the vehicle revealed a small white rock like substance on the passenger floor board next to Breen's purse. I field tested the small white rock substance using a SIRCHIE Nark Cocaine ID swipe, which field tested positive for crack cocaine. Breen was then read her constitutional warnings from a card I keep in my uniform pocket. Breen acknowledged that she understood her rights and agreed to talk to me. Post Miranda, Breen stated "we both are users".</p> <p>Based on my lawful traffic stop and subsequent investigation, Breen was placed under arrest for Possession of a controlled substance without a prescription contrary to F.S.S. 893.13(6)(a). Breen was searched prior to entering my marked patrol vehicle wearing a blue sports bra, green shorts, and black shoes. Breen was then transported to the North Palm Beach Police Department for processing. Breen was issued a citation for Possession of a controlled substance without a prescription contrary to F.S.S. 893.13(6)(a), citation #: A87QJFE. Pharo was issued a written warning for Improper Equipment (No tag light) contrary to F.S.S. 316.610(1), warning #: 5276.</p>
