On the 14 day of June, 2018 at 01:02 (Specifically include facts constituting cause for arrest.)

The following incident occurred in the City of Delray Beach, Palm Beach County, Florida.

On 06/13/2018 at 2331 hours, I responded to Salt Seven located at 32 SE 2nd Ave in reference to a disturbance. Upon arrival, I met with the manager of the establishment, Eileen Wolfer. Wolfer stated that a white female, later identified as the defendant, Jennifer Lynch, was heavily intoxicated and causing a scene near the main bar area. Wolfer stated that Lynch threw a drink at another patron who left the area prior to officer's arrival. Wolfer requested that Lynch be escorted off the property and be given a trespass warning. I met with Lynch inside the establishment where I asked her to walk outside to talk to her due to the loud music inside the establishment. Lynch was hesitant and after repeated requests to walk outside, she hesitantly complied. While outside and seated on a bench, Lynch would not stop yelling derogatory words towards the business saying "fuck you" and "fuck Salt Seven".

I ran Lynch through Teletype and when I verified that she was clear, Wolfer advised Lynch that she was no longer welcomed on the property. Lynch immediately started yelling loudly and mumbling words. I told Wolfer that she was free to leave but she was not allowed inside Salt Seven. Lynch then stood up and started walking towards the Salt Seven entrance stating that she was looking for her phone. I blocked Lynch's path and she insisted on going inside the business again to look for her phone. Officer Meridith and Kyotikki stood by with Lynch while I went inside to look for Lynch's phone. When I was unable to locate it, Lynch became even more irate and kept yelling that I was a "dick" and that she wanted to find her phone and go home. I tried explaining to Lynch that her phone wasn't inside and again Lynch attempted to go inside of Salt seven. I then grabbed Lynch's arm to stop her from going inside and Lynch tried to turn around saying "bye" and swung her right open hand towards my face in a slapping motion. As Lynch swung her hand and turned around, she fell to the ground. Officer Meridith and I were assisting in getting Lynch up to place her under arrest and she kept trying to
