

I responded to Target located at 650 N Congress Ave, Boynton Beach, Palm Beach County, Florida in reference to a shoplifting in report. Upon arrival I made contact with store LPO Bryan Vargas and W/F Jennifer Nuccilli in the LPO officer. Bryan stated he observed Jennifer select multiple items and conceal them in multiple bags including a bag from the purse section which Jennifer took out the paper stuffing in order to conceal additional items as she walked around the store. Bryan advised he then observed the subject pass all points of sale, making no attempt to pay for the merchandise and exited the store via the South entrance/exit doors where she was stopped by Bryan and taken back to the LPO office.

As I was speaking with Bryan, Jennifer stated that she would not make any statements and she wanted a lawyer present before any questioning. The total amount of the merchandise comes to \$354.21. Target was able to retrieve all of the merchandise at full retail value.

Due to the facts stated above, Jennifer Nuccilli was placed under arrest for felony retail theft pursuant to FSS 812.015 (8) and was TOT PBCJ.
