Upon my arrival at the Mobil station Summit Bv & Congress Av the driver was slumped over the wheel passed out. The engine was running and in park. As we were trying to awaken her the driver revs the engine but not moving. The driver puts the car in drive but is still not moving. The driver is the only occupant

OBSERVATION OF DRIVER:

The driver was sitting in the drivers seat. The driver is wearing green s/s shirt, denim shorts and sandals. The windows were up. The driver was having extreme difficulty following instructions. She had extreme difficulty putting the gear shift into the park position. Once she finally accomplished that task she opened the drivers door. Immediately I was greeted by a strong and distinct odor of an alcoholic beverage. As we walked away from the car the odor was still present. The odor grew stronger as she spoke. The drivers pants were open and just below her hips. her pink undergarments were down to mid thigh. The drivers hair was a mess, her eyes were extremely blood shot watery and glassy. Her speech was soft mumbling and hard to understand. The driver could not walk at first without the support of her car. She leaned on the car all the way to the front sitting on her hood. I was able to have her move to an area in front of my car and video.

The driver failed to keep head still, eyes failed to follow smoothly. looked everywhere but at the stimulus

WALK & TURN:

The driver failed to keep balance during instructions this was extremely difficult, stops walking to steady self, failed to touch heel to toe on all steps, failed to walk on the line stepped off several times, failed to keep arms down at side used arms for balance, failed to turn correctly had to stop and ask questions.

ONE LEG STAND:

The driver sways back and forth, she failed to keep arms down at side used arms for balance, she failed to keep foot up 6", continually puts foot down, failed to count properly.

FINGER TO NOSE:

The driver failed to keep eyes closed, failed to return arms to side, failed to use touch tip to tip, failed to keep head tilted. failed to use correct arm to touch nose. Never touched nose always touched side of nose and cheek. had to be instructed several times on how to complete this task

ROMBERG ALPHABET:

The driver failed to keep eyes closed, failed to stand still swayed more than two inches, failed to keep arms down at side used arms for balance, failed to recite the alphabet correctly, failed to keep head tilted back, said he never was taught the alphabet and was reciting the months of the year as the alphabet. She could not get them right either

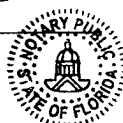

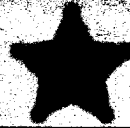

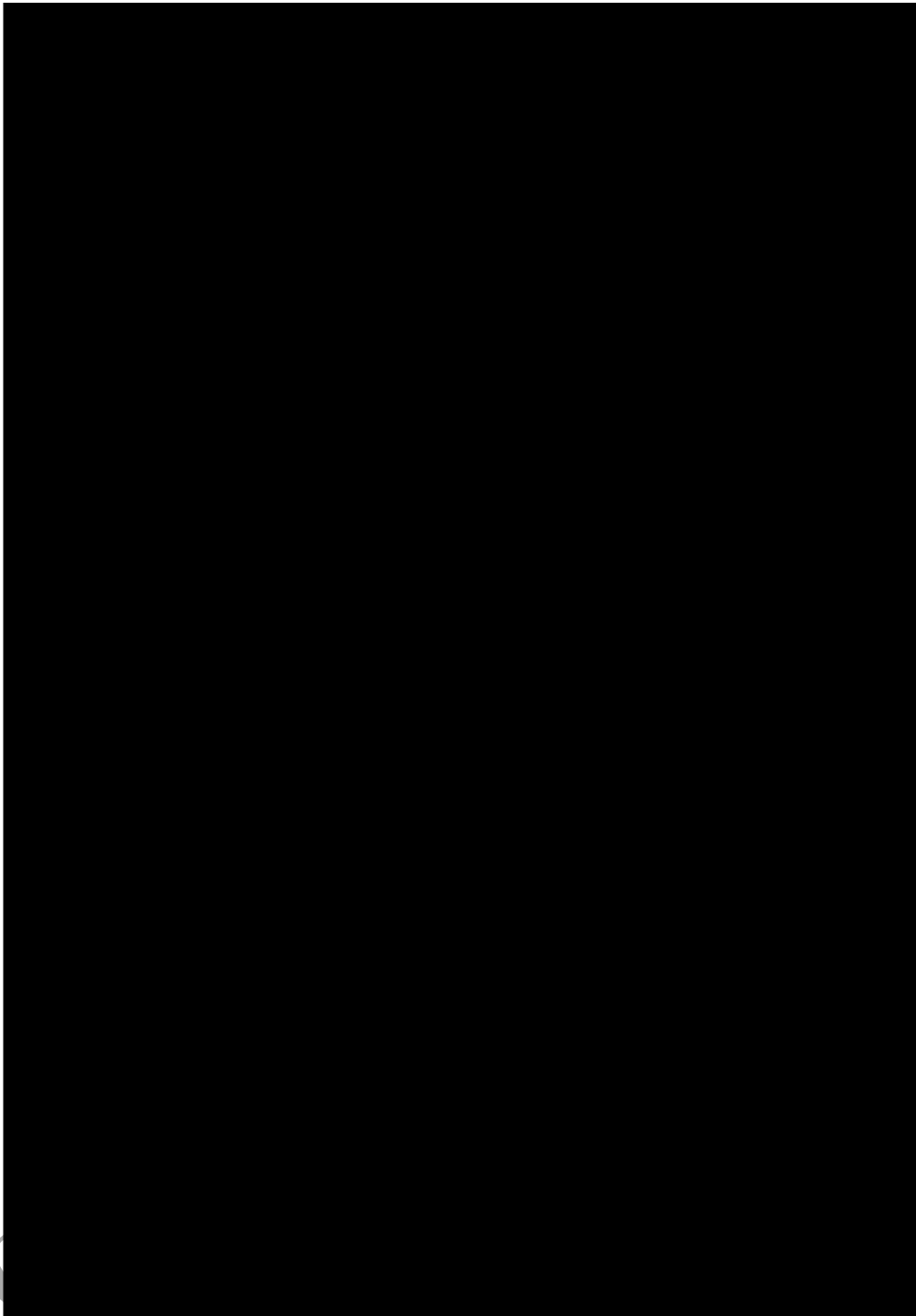
