



**Other Observations:**

Subject was asked to stand with their feet together and place their hands by their side. They were asked to focus on the stimulus and follow it with their eyes. Lastly they were told not to move their head to assist in following the stimulus with their eyes. Subject showed equal pupil size that tracked equally. Both eyes lacked a smooth pursuit. I saw distinct and sustained Nystagmus at maximum deviation. I also saw an onset of Nystagmus prior to 45 degrees in both eyes. Subject swayed while performing this task. Subject had to be reminded to keep her head still and follow the stimulus.

**WALK & TURN:**

Jenny was placed in the instructional stance for the walk and turn task. This task was explained and demonstrated to Jenny. During the instructions Jenny attempted to begin the task prior to being instructed to do so. Jenny was unable to maintain the instructional stance and stepped out of the position several times. Jenny acknowledged the instructions prior to performing this task:

During the task Jenny missed heel-to-toe steps and stepped off the line several times. Jenny used her arms for balance and paused several times to steady herself. Jenny did not turn as instructed. Jenny did not take the correct number of steps, taking 10 steps down.

**ONE LEG STAND:**

Jenny was placed in the instructional stance for the one leg stand task. This task was explained and demonstrated to Jenny. During the instructions Jenny attempted to begin the task prior to being instructed to do so. Jenny acknowledged the instructions prior to performing this task:

During the task Jenny swayed. Jenny had to be reminded to look down at her foot and put her foot down once prior to 30 seconds elapsing.

**FINGER TO NOSE:**

Jenny was placed in the instructional stance for the finger to nose task. This task was explained and demonstrated to Jenny. Jenny acknowledged the instructions prior to performing this task:

During the task Jenny missed touching the tip of her nose, and failed to return her arm to her side several times. Jenny failed to keep her head tilted back. After the second right command Jenny began to alternate touching her nose with her left and right, without being instructed to do so.

**ROMBERG ALPHABET:**

Jenny was placed in the instructional stance for the Romberg alphabet task. This task was explained and demonstrated to Jenny. Jenny acknowledged the instructions prior to performing this task:

During the task Jenny swayed and incorrectly reciting the alphabet stating "H, I, L" Jenny requested to repeat the task a second time in Spanish. Upon performing the task again I observed Jenny swaying again. Jenny was able to correctly recite the alphabet in Spanish.


