On the 8th day of April 2018 at 1:10 A.M P.M (Specifically include facts constituting cause for arrest.)

I responded to 11101 Southern Blvd, Out Back Steak House, in the Village of Royal Palm Beach, in reference to a delayed report of vandalism that was done to the front door of this establishment. I made contact with the complainant / manager, Andrea Vogel. The complainant said that on this date at approx. midnight she checked the doors of the establishment to make sure they were secured. At 0130 hours the complainant made a final check of the doors and discovered that the right front door to the business was shattered. The complainant went outside and noticed that one of the metal chairs which was just outside the front doors had the legs bent and appeared to have been used to impact the front door.

I along with the complainant reviewed the in-store surveillance video and I was able to clearly see that at 0110 hours a unknown white male with a beard and wearing a base ball cap on backwards, short sleeve T-shirt walked to the front of the closed business. The suspect selected one of the metal chairs which were laying just in front of the front doors in the waiting area. The described suspect is seen picking up one of the chairs and intentionally threw it against the front door several times causing the glass to shatter. No entry was made into the business. The suspect is then seen calmly walking away in a westerly direction. It should be noted that D/S D. Smith responded to a domestic call (18-059838) at Bru's Room which is located at 11111 Southern Blvd. D/S Smith positively identified the suspect in the surveillance video smashing the front door with the chair as the same suspect in his domestic case. D/S D. Smith identified the suspect in the video as W/M Jereme, Michael, Pickren, DOB: 10-02-77 the same person he just dropped off at his residence in Royal Palm Beach, Fl.

On 04-09-18, at I made contact with the Outback Steak House manager who said that the estimated damage to the front door is \$1200.00 and the damage to the chair is \$200.00 dollars. The management wants to prosecute the suspect for the above listed damages. Based on the video surveillance footage and D/S D. Smith's identification of the suspect in the video I believe there is probable cause to arrest and charge W/M Jereme Michael Pickren, DOB: 10-02-77, with 1 ct of Criminal Mischief, in violation of F.S.S. 806.13 (1)(B)(3).
