Upon my arrival, I made contact with the caller Jeremiah Bennett who was waiting for police assistance in the parking lot. It should be noted that Bennett said that he was under the influence of alcohol. Bennett said that his roommate of one year, Rosalind Hill assaulted him. Bennett said that he returned home from a local bar when Hill attacked him after entering into the apartment. Bennett said that Hill was upset with him because she thought that she was pregnant with his child. Bennett stated that he and Hill had sex one time and were never involved in a romantic relationship. According to Bennett, Hill pushed him multiple times and attempted to take his keys from him. It should be noted that Bennett and Hill are not in a domestic relationship.</p> <p>Officer Williams made contact with Hill who was crying hysterically inside of the apartment. Officer Williams observed that Hill's forehead was swollen and had a small laceration approximately one inch in diameter on the right side of her forehead. Hill advised the following verbally and in a sworn recorded statement. Hill said that Bennett came home from the local bar and started banging on her bedroom door until she got up and opened it. Bennett then accused Hill of having his cat inside of her bedroom along with other items. Hill allowed Bennett search the inside of her bedroom for his cat and items. While on the ground, Bennett smashed her head onto the tile floor approximately 4-5 times. Bennett proceeded to hit Hill's head onto the coffee table and into the living room wall. Once Hill was able to get up off of the floor, Bennett pushed Hill's head into the front door. Bennett proceeded to grab a wine bottle that was located in the living room and hit Hill in the face with it one time. Bennett then exited the residence and called the police.</p> <p>Officer Williams Observed a wine bottle located by the front door. The wine bottle was recovered and placed into Riviera Beach Evidence. Hill advised Officer Williams that she wanted to press charged and signed an affidavit of complaint. Based on the above facts, Officer Williams has probable cause to charge Bennett with one count of aggravated battery and one count of simple battery. Bennett was transported to St. Mary's Hospital for medical clearance. Bennett was then transported to Riviera Beach Headquarters for processing and later to the Palm Beach County jail.</p> | | | | | | | | | | |
