On the 3RD day of SEPTEMBER 20 19 at 2150 A.M. P.M. (Specifically include facts constituting cause for arrest.)

On Tuesday, September 3, 2019 at approximately 21:05 hours, I responded to eastbound Glades Road, west of Boca Rio Road (in front of the Holiday Inn Express) in the unincorporated Boca Raton, Palm Beach County Florida, in reference to a disturbance call.
Deputy D'Avanzo #29008 and I made contact with a white male later identified by his Florida driver license as Brian Andrew Hellman. Brian who is an Uber driver advised the following in a sworn witness statement. Brian picked up a white male later identified by his Florida ID card as Jesse Abraham Abitbol in the vicinity of Lyons Road and Glades Road (as per victim statement). According to Brian, Jesse sat on the rear right seat of his vehicle. Jesse was on the phone verbally arguing with someone. Brian stated Jesse appeared to be heavily intoxicated due to the strong smell of alcohol and smell of "pot" coming from his person. According to Brian statement Jesse started to demand to turn around and was acting very "rude and annoying". Brian stated Jesse "flick" (intentionally struck) the back of his head near his right ear area. Brian pulled his vehicle over and ordered Jesse to step out and called 911. Brian advised he is willing to press charges.

Jesse who was recording the whole encounter on his cellphone advised he was picked up by the Uber driver and without a reason began to act disrespectful with him. Jesse stated multiple times he did not wanted to talk to us and said he had a lawyer. Jesse's behavior was very belligerent using profanity. his speech was slurred and he was having trouble standing on his feet. Jesse was placed under arrest at 2119 hours. Handcuffs were double locked and checked for proper fit. Jesse was placed on the rear seat of my marked patrol unit. While on camera (audio and video) I began to to read his Miranda warnings to what he refused to acknowledge every phrase and finally started to scream profanities. It should be noted that while Jesse was on the back seat of my patrol car he began to use profanity against everyone on scene.

Based on the facts, circumstances, witness statements, and investigation I do find probable cause to charge Jesse Abraham Abitbol with Battery (Florida State Statute 784.03(1)(a)(1) first degree misdemeanor).

Jesse was transported to the Palm Beach County Jail for booking in the rear seat of my marked patrol unit.

This case is clear by arrest.
