

OFFICER'S NARATIVE: On 08/03/19, I was dispatched to 8 E Atlantic Ave in reference to a vehicle crash involving 2 vehicles. Upon arrival, I made contact with Ofc. Gordon who advised he had suspicion that the subject, Jesse Eftis was driving under the influence. Ofc. Gordon and Ofc. Schwartz advised that they observed Eftis in the restaurant/bar, Tin Roof, for several hours prior to the crash. I then made contact with Eftis who was sitting on the sidewalk at the time. Eftis was then advised that I would be conducting a DUI investigation.

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEFENDANT BEHIND THE WHEEL OF THE VEHICLE): Ofc Gordon advised that while he was on foot patrol in the 1st block of E Atlantic Ave, he witnessed the subject, Jesse Eftis, crash his vehicle into the back of a blue 2015 Hyundai (IB50JA). Eftis was driving a silver Honda (VFS5856). Ofc Gordon advised the passenger in the subject's vehicle had to be transported to the hospital due to injuries sustained from the deployment of the vehicle's airbags. Ofc. Gordon and Ofc. Schwartz advised that Eftis was in actual physical control of the vehicle at the time of the crash.

OBSERVATION OF DRIVER: Jesse Eftis was unsteady on his feet. Eftis had glassy, reddened eyes. It also appeared that Eftis had urinated in his shorts.

DRIVER'S STATEMENTS: Eftis did not make any statements, but agreed to perform the road side tasks.

ODORS: Eftis's breath smelled of a unknown alcoholic beverage.

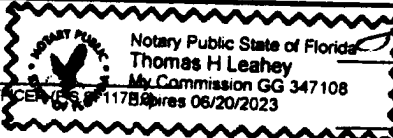


