

On October 14th 2019, I Officer Norbrothen, of the Florida Fish and Wildlife Conservation Commission (FWC) was on land patrol of Palm Beach County in Wellington in the Storm Water Treatment Area 1 East (STA1E). STA1E is owned and managed by South Florida Water Management District (SWFMD). I was in my class "c" rough duty uniform in my marked patrol vehicle.

At approximately 1853 hours I observed two white males, each with fishing poles in hand, standing by the waterline of a canal in the southeast corner of STA1E. The subjects were walking away from me and avoided looking in my direction. The area of STA1E I observed the two subjects in is unlawful for the general public to be in, unlawful to fish in, and considered trespassing on SFWMD property.

I made contact with the two individuals and told them it was against the law to be where they were and asked for their fishing license or identification. Neither individual had a fishing or driving license on them. I asked for their names and dates of birth and was told William J Gabriel 1/7/2000 (FL DL G1649300000070) and Dustin J Wallace 9/13/2000. When subject Wallace said the year from his date of birth he said "nineteen, no, two thousand" indicating to me he could be lying about his date of birth.

I ran Gabriel through FCIC/NCIC and prior stops with FWC. On 6/23/19 Gabriel was stopped in the same STA for the same trespassing violation. He was issued a written warning for violation of Florida State Statute (FSS) 373.613 – Violation of Florida Administrative Code Pertaining to South Florida Water Management Regulations – Florida Administrative Code (F.A.C.) 40E-7.523(1)

40E-7.523(1) – Entry onto and Exiting from district lands is only authorized at indicated access points.

I issued Gabriel a Notice to Appear (NTA) for the violation as he entered the STA from an non designated access point and entered an area of the STA closed to the public that was not an indicated access point.

I ran Wallace through FCIC/NCIC and came back with no results. He then told me he lived in Maryland. I ran Wallace through NLETS out of Maryland and no results came back. I told Wallace I could not find a record of him and he asked if I could turn my body worn camera (BWC) off. I said no. He told me Dustin Wallace was not his real name and he didn't want me to know who he was because he was on probation. He said his real name was Jesse J Valerga 9/13/1999. I placed Valerga under arrest at approximately 1908 hours for identifying himself to me with a false name while in my lawful investigation for trespassing in the STA1E and not having a fishing license.

I charged Valerga for violation of FSS 901.36(1) - Giving False Name to Law Enforcement, a first-degree misdemeanor. I also issued Valerga a warning for trespassing on the STA.

At approximately 1947 hours I booked Valerga into Palm Beach County Jail at Gun Club.
