The undersigned certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the above named Defendant committed the following violation of law. On the 25 day of April, 2018 at 04:10 (Specifically include facts constituting cause for arrest.)

On 4/25/18 at approximately 0354 hours I responded code 3 (lights and sirens) to the area of 1600 W Glades Road in reference to a female passed out behind the wheel of a silver Chevrolet. The caller wished to remain anonymous but advised BRPD dispatch that the female appeared to be "on something".

I arrived on scene and observed a W/F (later identified as Jessica Sticken 11/04/95) passed out behind the wheel of a gray Chevrolet bearing FL tag 180-INP. It should be noted the vehicle was still in "drive". Officer Tyson and I knocked on the vehicle windows several times in order to get Jessica's attention. Jessica woke up, however still did not realize Boca Raton Police were at her vehicle and she fell back asleep and the vehicle began to roll forward. For the safety of Jessica and others, Officer Tyson utilized his BRPD baton to smash the front passenger window to gain entry. The vehicle appeared to have come to a complete stop and Officer Tyson gained entry into the vehicle to put it in park.

Once the vehicle was in park, I asked Jessica to exit the vehicle to speak with me. As she was exiting her vehicle she appeared very lethargic and unsteady on her feet. As I continued to speak with Jessica I could smell a strong odor of alcoholic beverages coming from her person. Additionally, her speech was heavily slurred and her eyes were red and bloodshot. I asked Jessica what street she was on and she stated Glades Road and that was going home. She stated she was going to "east road" and didn't answer my question about where she was coming from.

I explained to Jessica my observations and asked her if she would attempt the standardized field sobriety tasks (SFST's) to dispel my alarm that she was impaired. She stated no. I explained the tasks were voluntary, but if she refused, it could be used against her in a court of law, I could use all my observations and the events that occurred here today as a basis to build probable cause if I decided to make an arrest,

and she was forcing me to make my decision on everything I had observed to that point. I asked her again to attempt the roadside tasks and she stated no.

Based on the totality of circumstances, my observations, at 0410 hours on 04/25/18 I placed Jessica Sticken under arrest for DUI pursuant to FSS 316.193(1). The vehicle was towed by Emerald Towing. Jessica was transported to BRPD for processing.

Officer Rafalko conducted The Intoxilyzer 8000 testing. Jessica provided breath samples of .167 and .168.

Jessica was given the court date of 06/04/2018 at 8:30am. After processing she was transported to PBCJ.
