Then Jessica engaged in a physical altercation with [REDACTED] [REDACTED] had several scratches on her neck, arm and forehead. She also appeared to have a bite, which appeared to have been made by Jessica. Jessica had some scratches on her wrist and some minor bruises. I could not determine how recent the bruises were. Due to the physical evidence, it was determined that Jessica was the primary aggressor in this incident. Therefore, probable cause exists for the Arrest of Jessica Ashley Nicodemo for Domestic Battery, pursuant F.S.S 784.03 (1A1).
