Palmetto facing southbound at a solid redlight. The vehicle was stopped in front of the solid stop bar in the roadway which would effect the ability of a pedestrian to cross the roadway. I turned on my in-car camera and began following the vehicle. I followed the vehicle for 12 blocks and speed paced the car using Unit#316 going 50 mph in a 35 mph zone. Unit#316 is speed calibrated semi annually. Also, the vehicle swerved out of its lane on two different occasions. The vehicle stopped at 1700 S. Federal Hwy. Once the car was stopped, I approached the driver's side portion of the vehicle and made contact with a W/F identified as Jessica Veltri. Veltri was fumbling through her documents and trying to find her license, registration and insurance. Veltri informed me that she driving home from her place of work. While speaking with her, I detected the odor of alcohol coming from her person, her speech was slurred and her eyes were bloodshot. Ofc. Galazka was on scene as back-up.</p> <p>Veltri exited her vehicle and informed me that she takes Trazodone and Clonazepam, which are narcotics. Veltri stated she consumed the medications earlier in the day. While speaking Veltri, she was swaying and continued to slur her speech. Veltri stated that she had not consumed any alcohol tonight and did not feel impaired. When asked where we were at right now, Veltri seemed confused and said that we were somewhere between "Federal and 10th". She then stated we were between "Camino and Federal."</p> <p>I explained and demonstrated each task before she performed them.</p> <p>The first task was the Horizontal Gaze Nystagmus. While observing HGN, each eye had a constant jerking while at maximum deviation. Lack of smooth pursuit was present in both eyes. Onset prior to 45 degrees was present. While in close proximity with Veltri, the odor of alcohol became stronger.</p>

SUPPLEMENT

The second task was the Walk and Turn. Before starting the task, Veltri said, "I know why you have to do this" and admitted to consuming wine earlier in the night. She could not maintain the starting position because she was falling off the line. While performing the task she used her arms for balance. She did not go heel to toe the entire time. She walked 10 steps instead of 9. Upon returning, she kept falling off the line and even began walking backward at one point. She did not go heel to toe at all.

The third task was the One Leg Stand. Veltri started the exercise early. She did not count out loud during the task at all. She used her arms for balance. Veltri stopped at 8 seconds and asked if she should start again or "use another foot." I had to re-explain the task to her. She could not maintain her balance for even a short amount of time.

The fourth task was the Finger to Nose (L-R-L-R-R-L). L- Held her finger to her nose. R- Held her finger to her nose. L- Fell off balance. R- Veltri was swaying. R- Held her finger to her nose. L- Missed the tip of her nose and held her finger.

The fifth task was the Rhomberg Alphabet. Veltri stated she could complete the task without incident. Veltri got to the letter E and then said G, F, G and then corrected herself.

Based on my investigation, I placed Veltri under arrest for DUI per F.S.S. 316.193(1) and transported her to the Boca Raton Police Dept. for processing. Ofc. Frenz conducted the Intoxilyzer 8000. While in the DUI room, Veltri provided the breath samples of .192% and .192%.

Veltri was later transported to the Palm Beach County Jail. The vehicle was towed by Emerald Towing and the video of the roadside exercises were uploaded into BRPD Evidence.


