On 10/12/17 I was dispatched to 409 Ebbtide Drive, in reference to a suspicious incident.


When I arrived I saw a W/F, later identified as Jessica Louise Saltzman (DOB 05/23/83), standing in front of the residence with what appeared to be blood on her right hand. In between the two vehicles that were parked in the driveway of the residence, were what appeared to be broken glass bottles. While speaking to Saltzman, I immediately detected an obvious and strong odor of an unknown alcoholic beverage emitting from Saltzman's person and face area. Saltzman stated to me that she had been drinking and did not want her husband to have full custody of their son.

I later made contact with Craig Simmons (W/M DOB 12/18/64). Simmons told me that he had been out with their son and when he returned home he saw Saltzman standing in the parking lot and immediately called 9-1-1.

North Palm Beach Fire Rescue responded to the scene to evaluate injuries and cleared Saltzman on scene.

During my investigation, Simmons asked me to do a walk-through inside of the residence to make sure nothing was disturbed inside. While I was in the doorway, Saltzman suddenly closed the distance and ignored commands to stop, step back, and to not come any closer. With clinched fists, Saltzman raised her hands and shoved Sergeant J. Ortiz ID #9749 and myself, and lunged toward the door in attempt to go inside the residence. Saltzman repeatedly said to Police Officers on scene "Don't touch me niggers", "I fucking hate you", and "get the fuck off me".

Police Officers escorted Saltzman to the ground and placed her in handcuffs with her hands behind her back, handcuffs double locked and checked for proper spacing.

Saltzman was wearing a yellow shirt and blue jean shorts at the time of arrest. Saltzman was thoroughly searched prior to getting into my patrol vehicle.

Saltzman was transported to the North Palm Beach Police Department for processing. During processing, Saltzman had blood coming from the laceration on her hand and North Palm Beach Fire Rescue and had to be transported to Palm Beach Gardens Medical center to be cleared.

Saltzman was subsequently transported to the Palm Beach County Main Jail without incident.
