*****SUPPLEMENT*****

I was traveling eastbound on 6th Ave S approaching the intersection of A St in marked PBSO patrol vehicle (08614) within the City of Lake Worth. During that time, I observed a 2020 GMC SUV bearing FL tag (LWPJ28) also traveling eastbound in front of my vehicle enter the left turn lane just west of A st. As the vehicle traveled eastbound on 6th Ave they entered the intersection of A st and made a u-turn at 6th Ave S and A st in order to head back westbound. It should be noted that there is a posted NO U TURN sign in the above intersection. At that point, I traveled after the vehicle and effected a traffic stop on the vehicle. As I approached the vehicle on the passenger side the driver (later identified by FDL as Jessica L Carter) appeared confused and did not know right away that I was on the passenger side as she had her driver side door open. As I knocked on the passenger side window, to gain the attention of the driver she unlocked the passenger side door and singled for me to open it. Once I opened the door and made verbal contact with the driver, I could smell the aroma of an unknown alcoholic beverage emanating from the interior of the vehicle. While speaking and explaining to the driver the reason for the traffic stop(citation issued CIT #ACKJ2WE), I noticed that when she responded her speech was thick and slurred, her eyes were glassy and the aroma of the unknown alcoholic beverage intensified as she spoke. Based on my physical observations of Carter, D/S Tejada 31814 was contacted to come to the scene in order to conduct a DUI investigation.

This concludes my involvement in this case.

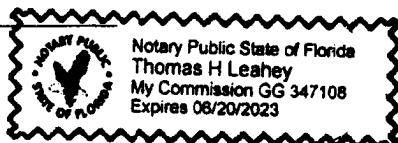

THE DEFENDANT TOOK THE FIRST 9 STEPS WHICH WERE NOT HEEL TO TOE. THE DEFENDANT STEPPED OFF THE LINE 6 SEPERATE TIMES ON STEPS, 2, 3, 4, 5, 6, AND 7. THE DEFENDANT IMPROPERLY TURNED AROUND. THE DEFENDANT THAN TOOK 8 STEPS BACK. THE DEFENDANT DID NOT WALK HEEL TO TOE ON EITHER OF THE STEPS BACK. THE DEFENDANT ALSO USED THE PATROL CAR SIDE TO KEEP HER BALANCE. THE DEFENDANT ALSO USED HER ARMS FOR BALANCE.
