**Narrative:**

In the city of Boynton Beach, within the county of Palm Beach, I, Officer D. Whitefield, was dispatched to Las Ventanas, 1499 S. Federal Hwy #118, in reference to a domestic disturbance.

BBPD Dispatch advised that an anonymous caller stated that four doors down from their apartment they could hear a male and a female physically fighting. Upon arrival, I observed several small drops of blood on the floor of the living room and kitchen. I made contact with w/m Anthony Reyes (DOB 06/22/1994) while Officer D. Wagner stepped outside to speak with the other involved party, w/f Jessica Leinbach (DOB 01/31/1992). In a sworn statement captured via my body worn camera, Reyes stated that he has lived with and dated Leinbach for the past seven months and she is currently two months pregnant with his child. He stated that this evening, he found drug paraphernalia in the apartment and knowing that Leinbach use to have a drug addiction, he confronted her. He stated that Leinbach became defensive and began throwing random items from the apartment at him. Reyes stated that she then began hitting him in the face and body. He had several lacerations on his neck, chest, and both arms, each approximately 3"-5" inches long. He refused medical treatment for his injuries.

Leinbach's statement was captured via Officer Wagner's body worn camera. She denied that the argument ever became physical and stated that they got into a verbal argument after he became jealous while looking through her cell phone. She had no visible marks or bruises. After speaking with Officer Wagner, I asked Leinbach about the scratches on Reyes' body and she stated that she "threw things at him" which caused the "situation to escalate from there", however she stated that she was not intentionally trying to harm him. Photographs of both involved parties were taken and uploaded to Adams as evidence.

Based on the aforementioned, I find probable cause to charge Leinbach with one count of Simple Battery Domestic Violence in violation of F.S.S. 784.03.1a1. She was placed under arrest and transported to BBPD for processing and later to the Palm Beach County Jail without incident.
