I observed the vehicle fail to stop for the stop sign at Lighthouse Dr. & Westwind Drive. As the vehicle continued to travel eastbound on Lighthouse, it began to swerve over the lines. 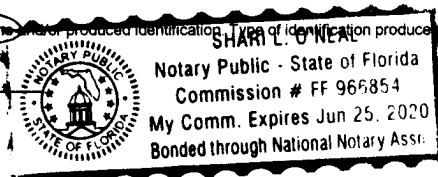

Stops walking to steady self (Mates stop walking on steps 2, 3, 8 and on steps 3 and 6 on the way back. Misses heel-to-toe (Mates misses heel-to-toe on steps 1, 2, 3, 4, 5, 7, 8, 9 and on 1, 2, 3, 4, 5, 6, 7, 8 and 9 on the way back). 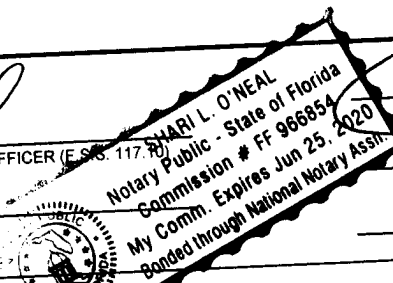
