WALK & TURN

Phipps lost her balance during the instructional phase one time. Phipps used her arms for balance on the first step. Phipps lost her balance on the second step, missing heel to toe, stepping off the line, and again using her arms. Phipps stated that she could not do the task. She said "I am too fucking nervous". Phipps agreed to attempt the task again. She quickly lost her balance and again said she could not do the task.

Although Phipps only completed a small portion of the task, she displayed four of the eight validated clues.

Phipps hesitated before agreeing to complete the next task.

ONE LEG STAND:

Phipps raised her left leg. Phipps was swaying visibly during the task. She placed her foot down on "1000-9" and asked what to do next. I told her to keep going. Phipps hesitated before continuing, asking what to do. Phipps raised her foot, started counting from 1000-1. She immediately placed her foot back down on the ground, using her arms for balance. Phipps raised her foot again and continued to "1000-4" until I terminated the task. Phipps displayed three of the four standardized one leg stand clues.

FINGER TO NOSE:

L1: Phipps touched her nose with the pad of her finger on the approximate middle of the bridge. Phipps did not bring her finger back down to the side. I reminded her to touch her nose and bring her finger back down to the side. R2: Phipps touched her nose on the right side of the bridge, at the very top of her nose where it curves around her eye. Phipps again did not bring her finger back down and I again reminded her. L3: Phipps touched the tip of her nose, but with the pad of her finger. Phipps again did not bring her finger down, and I reminded her again. R4: Phipps touched her nose over her left nostril. Phipps did not bring her finger down. I did not remind her. R5: Phipps kept her finger in place. Phipps again did not place her finger back down to the side. L6: Phipps touched the tip of her nose with the pad of her finger.

ROMBERG ALPHABET:

Phipps had an approximate 2" sway side to side during the task. Phipps stated the alphabet correctly.



D.U.I. PROBABLE CAUSE AFFIDAVIT

PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)
I observed a 2016 white Ford 4-door bearing Florida License Plate 499LJD traveling west on West Indiantown Road from the intersection with Alternate A1A. The vehicle was originally traveling in the middle lane. I observed the vehicle bearing to the right side of its lane and crossing into the right hand lane with its passenger side tires. It did not affect any other traffic. The vehicle was traveling at a speed of 55-60 miles per hour. I observed the vehicle again bear to the right and about half the vehicle was in the middle lane and the other half was in the right hand lane. After about 4 seconds, the vehicle's right hand turn signal activated and the vehicle changed lanes into the right hand through lane. The vehicle continued to drift to the right of its lane. The vehicle's passenger side tires again left the marked lane of travel and crossed over the solid white line demarcating the bicycle lane from the roadway. This persisted for about 2-3 seconds before the vehicle completely reentered its lane of travel. The vehicle then activated its left turn signal and changed lanes back to the center then to the left hand travel lane. The vehicle slowed to the posted speed limit and pulled into the left hand turn lane for southbound South Delaware Boulevard. The vehicle stopped with its front tires across the marked stop bar and front end over the crosswalk. The vehicle's rear tires were behind the stop bar.

OBSERVATION OF DRIVER:

Phipps had bloodshot glassy eyes. She was slurring her speech and trailed off when answering questions.

Phipps hesitated when asked to complete roadsides. I explained Taylor Warnings to her and the purpose of the tasks. Phipps was indecisive and I asked her several times for an answer. Phipps eventually agreed to complete the tasks. I emphasized that they were voluntary, but that there were consequences to refusing to complete the tasks.

DRIVER'S STATEMENTS:

Phipps stated that she had "only a little bit" to drink when I asked her. Phipps stated she was going to a house on Delaware Boulevard but was unable to provide the address. Phipps stated she was coming from "the boat" but could not or would not elaborate further when asked.

ODORS:

Odor of unknown alcoholic beverage on breath.


