Officer Galazka was blocking the southbound lanes of North Federal Highway. He was utilizing his marked patrol vehicle with traffic cones. The vehicle had its emergency lights activated.</p> <p>At 2341 hours, a vehicle being driven by Jessica Porras Ramos was southbound on North Federal Highway. The vehicle did not follow the traffic pattern that was established. Her vehicle struck Officer Galazka's vehicle causing damage to both. See his report for further.</p> <p>I was stopped in the northbound lanes of North Federal Highway, just south of NE 40th Street. After hearing the loud impact and seeing Officer Galazka's vehicle move to the south, I drove over to his location. I observed Jessica Porras Ramos in the driver's seat of her vehicle. I turned off the engine as she was being unresponsive. She had a dazed look upon her face. At first she was not answering our questions. BRFD was requested to the scene.</p> <p>CSO Lintzeris completed the traffic crash report. CST McDonald took digital photographs of the scene and vehicles.</p> <p>Porras Ramos was not complaining of any injury. BRFD cleared the scene. She stated she was coming from Senor Burrito in Delray Beach where she had 4 drinks. She later changed that to 2 drinks and then to 3 margaritas. She has no medical conditions and takes no medications.</p> <p>I could smell a strong odor of an alcoholic beverage coming from her breath. Her eyes were red and glassy. Her speech was slurred. She began to cry and get emotional.</p>

I set up my in car camera in an adjacent parking lot. I asked her to walk to the front of my vehicle. She was swaying while walking.

I read her The Miranda warnings. She stated she hit the other vehicle, because she blacked out after arguing with her husband on the phone. I explained my crash investigation was complete. I asked her if she would attempt the road side tasks. She stated she would.

The first task was the horizontal gaze nystagmus. She was swaying while standing. There was a lack of smooth pursuit in each eye. Distinct and sustained nystagmus at maximum deviation in each eye. Onset of nystagmus prior to 45 degrees in each eye.

The second task was the walk and turn. She left the starting position. She started walking on the wrong foot. She did not touch heel to toe on any step. She was not counting out loud.


The third task was the one leg stand. She raised her right leg. Her foot was not 6" from the ground. She kept dropping her foot to the ground. She was using her arms. She was swaying. She started to bounce and hop so the task was stopped, so she would not fall.

When I attempted to conduct the finger to nose, she stated she wanted to stop.

On 9/15/2016 at 0020 hours, I placed her under arrest. She began to tense her arms and pull away. She had to be carried to be placed inside my vehicle. I transported her to The BRPD.

Officer Crawford conducted The Intoxilyzer 8000 testing. I asked her if she would provide a breath sample. She did not answer, so I read her Implied Consent. She then stated she would provide a breath sample. She provided the breath samples of VNM, VNM, .234%, and .244% BrAC.

She was charged with DUI FSS 316.193(1). She was given the court date of 10/17/2016 at 8:30am. The video was submitted into property. After processing she was transported to The PBCJ.


