On November 25, 2019, at approximately 1200 hours Your Affiant was working in a uniformed capacity assigned to the SID Division, Criminal Apprehension Team. Your Affiant was wearing an exterior vest with bold white lettering of the word POLICE displayed to the front and back driving an unmarked WPBPD patrol vehicle. At the listed date and time Your Affiant was driving west on Palm Beach Lakes Boulevard approaching North Australian Avenue. Your Affiant observed a blue 2019 Ford Escape bearing FL tag EZXM43 traveling west on Palm Beach Lakes Boulevard approaching North Australian Avenue. Your Affiant observed the above listed vehicle aggressively changing lanes, while continuing to drive west on Palm Beach Lakes Boulevard, failing to use its signal. The vehicle continued to swerve through traffic from the outside lane across all lanes of traffic to the inside lane and back to the outside lane. While approaching Palm Beach Lakes Boulevard and Congress Avenue Your Affiant observed the above listed vehicle almost cause a crash due to its aggressive lane changes. Due to the driving pattern Your Affiant conducted a traffic stop on the above listed vehicle in the 1800 block of Palm Beach Lakes Boulevard. While the vehicle was attempting to pull over Your Affiant observed the sole occupant of the car, later identified as Jessica Hellman, making downward movements with her left hand towards her upper torso area. When Your Affiant approached the vehicle, a plastic bag was immediately noticed sticking out of the top right of Hellman's shirt where she just previously had her hands moving in. Your Affiant asked Hellman why she was driving was erratically at which point she stated she was sick as was just going home from the court house. While conducting the traffic stop Your Affiant was made aware Hellman was on Florida Inmate release status for narcotics. Hellman advised she had no narcotics inside of her vehicle or on her person and gave Your Affiant verbal consent to search inside of her car. Hellman removed herself from the vehicle at which point Your Affiant noticed a large bulge Hellman's upper chest area, the same area where the plastic bag

was observed and the same area Your Affiant observed Hellman moving her hand in. It should be noted that Hellman was wearing clothing that was tight to her skin. Based on the above listed facts Your Affiant request a female officer to respond to the scene to conduct a pat down of Hellman for it was believed she was concealing illegal narcotics inside of her bra. Officer Goldberger responded to the scene at which point Hellman handed over a plastic bag (removed from her upper right chest area) containing 12 capsules filled with a white like powder substance which Your Affiant immediately recognized as suspected Fentanyl. Hellman also removed a clear plastic bag containing 12 white circular pills marked with "ASC 116" which she advised were her methadone pills. Hellman was transported to the WPBPD for further investigation. Kauff's towing responded and removed the vehicle from the scene. Hellman was read her Miranda Rights from a WPBPD issued Miranda card which she signed and advised she understood. Post Miranda Hellman advised she went the area of 16th Street and North Dixie Highway after leaving the court house in attempts to buy Heroin. Hellman stated she met with a white female who gave her the 12 capsules for twenty dollars a capsule. Hellman stated she has been addicted to Heroin for a year and a half and is currently in a drug/methadone rehab. Hellman advised she has bought from the same white female during that time. The 12 capsules weighed 2.0 grams and NIK tested positive for Fentanyl. The narcotics were placed into WPBPD evidence. Based on the above facts Your Affiant has found probable cause to arrest Jessica Hellman for possession of Fentanyl under FSS 893.13(6)(A).
