On Friday, April 20, 2018 at approximately 23:50 Hrs., while on routine patrol I observed a black Nissan Altima exit the plaza on the SW corner of Kirk Road and Forest Hill Boulevard. The vehicle crossed three lanes of traffic to attempt to enter the turn lane to go Northbound on Kirk Road from Forest Hill Boulevard. As I approached the turn lane, I noticed two pick-up trucks stopped in the turn lane with the occupants out of their vehicles.

I rolled down my window to check on the occupants of the pick-up trucks, and they pointed to the black Nissan Altima and said that it had just hit their vehicle. I observed some crash debris and a dent to the pick up truck. The Nissan Altima had made the turn to travel Northbound on Kirk Road and was moving at a speed faster than the posted speed limit. I was unable to get a tag or clear driving patter at first as there was another vehicle between my patrol vehicle and the Nissan Altima.

As we approached Summit Boulevard and Kirk Road, the Black Nissan Altima failed to come to a complete stop at the red light before making a right hand turn on to Summit Boulevard. The vehicle continued East bound on Summit Boulevard at a high rate of speed and made a right hand turn onto Davis Road. I had not yet activated my overhead emergency lights, yet it seemed as though the driver of the vehicle was attempting to elude me.

I was finally able to initiate a traffic stop as the driver pulled into a parking space at 3750 Victoria Drive. I made contact with the driver, later identified as Jill Ann Tachen (W/F - D.O.B. 9/17/1970) by her expired Florida Driver's License. Jill had slurred speech, her eyes were red and glassy, and she appeared to be confused when I asked for her driver's license, insurance and registration.

Based on Jill's slurred speech, eyes being red and glassy and her state of confusion, I had a strong suspicion that she was driving under the influence of alcohol. When I asked Jill where she was coming from, she said McKenna's which is a bar restaurant in the plaza I witnessed her vehicle exit. I asked for a DUI unit to respond and DUI 10 (D/S E. White I.D. 7209) responded and completed his investigation.

On the 20 day of APRIL 20 18 at 2335 A.M. P.M. (Specifically include facts constituting cause for arrest.)

I made contact with the driver who was currently sitting in the driver seat of the Nissan that was stopped by D/S Manfredi. She was later identified as Jill Ann Tachen by her Florida driver license. During my interview I noticed the driver's eyes were red, watery and glossy. Her cheeks were flushed and mouth was dry. Her speech was slurred and her movements were slow and lethargic. I could smell a strong odor of an unknown alcoholic beverage emanating from the inside of the vehicle. She appeared intoxicated. I told the driver I had a suspicion that she had been drinking an unspecified amount of alcoholic beverages. She told me she met a guy while she was out. She told me he bought her "Fireball" shots and she drank too much of them. I asked if he would consent to performing Standardized Field Sobriety Evaluations (SFSTs) for the purpose of determining if he was impaired while operating a motor vehicle. She declined. I explained Taylor Warnings that informed her performing the SFSTs were voluntary and she did not have to comply. However if she did not comply I would be left with the evidence before me {previously mentioned indicators and D/S Manfredi's observation of her vehicle in motion} which could be strong basis of her being placed under arrest for DUI. I asked if she understood the warnings. She told me she did understand. I asked if she would reconsider and comply with performing the SFSTs. She once again refused. I asked her to exit her vehicle and walk to the rear of her vehicle. I assisted by opening her driver side door. She exited the vehicle and began stumbling to the back of her vehicle. She was blue jeans shorts and a pink/white top. Her blue jean shorts were soaked in the front and rear. I suspected the wetness to be urine. I asked for a female deputy to respond to our location to search the defendant. During this time I noticed she was unsteady on her feet. At one point D/S Lauginiger and I had to grab her when she lost her balance. Investigator Lenndy Chiquita-Rodriguez arrived and did a search of her person. Afterward she placed her in handcuffs. I escorted her to my patrol car and sat her in the rear seat. She removed the handcuffs and placed them in her lap. We re-secured her. Afterward I began transport to the main jail breath analysis facility for further processing. Upon our arrival I escorted her into the facility and began a 20 minute observation period. During this time she ingested nothing into her body orally or otherwise. She also did not regurgitate. Afterward I escorted her into the testing room and asked her to provide breath samples for the purpose of determining her alcohol content. She refused. I read her implied consent in its entirety. I asked if she understood the consent and she said she did understand. I asked if she would reconsider her refusal and provide breath samples. She refused a second time. At this point she was deemed a refusal. I advised her of her Constitutional Rights and asked if she understood them. She acknowledged her "rights". I asked if she would consent to an interview. She refused.




