### **Probable Cause**

On 11/15/2019 I Trooper Cheyenne Mack (4323/1593) with the Florida Highway Patrol was on patrol in Palm Beach County, Florida. I was in a marked FHP unit equipped with overhead emergency lights and external siren. At approximately 8:47 PM I was dispatched to a crash that occurred on the southbound Interstate 95 (State Road 9) at 6TH Ave. I was informed by dispatch that the crash involved a vehicle that had run off the roadway into the ditch. I traveled to the location, upon my arrival I observed the vehicle blocking the roadway. I spoke with Palm Beach County Fire Rescue who advised me that they had observed a white female behind the wheel. I observed the female sitting on the shoulder with fire rescue and they had stated that she was refusing to go with them to the hospital. I approached the female and began asking her questions in reference to the crash she refused to speak with me and answer any questions about the crash.

I observed the female to have an unknown alcoholic emitting from her breath, she had blood shot watery eyes was unable to tell me what happened in the crash and what had occurred that night. So, I then I read Miranda Warning and advised her that I would be conducting a Dui investigation and she still refused to speak with me or comply. I advised her that she needed to stand up and she began struggling with me and the other firefighter and refused to follow any of my commands. Once I could place the handcuffs on her she still began to not comply with me and failed to listen to my commands. I placed the handcuffs behind her back and she was placed under arrest at 9:11 pm. Upon placing her in the car she began resisting and kicked me in the leg. I later identified the driver by FL/DL to be Jill Elizabeth Dummett (D530-425-71-843) with a DOB of 09/23/1971.

Based upon my observations and the totality of circumstances, Ms. Dummett was placed under arrest for DUI pursuant to Florida Statute 316,193,1 at 9:11 AM.

Ms. Dummett was then searched and placed in my patrol vehicle, and transported to the Palm Beach County Jail. While in transport to the Palm Beach County Jail there was an obvious strong odor of an unknown alcoholic beverage within my vehicle that was not present prior to placing the defendant in the vehicle.

The defendant arrived at the Palm Beach County Jail at 10:01 PM. After the defendant's 20min observation, the defendant was then given the opportunity to provide a sample of his breath which she refused at 10:32 PM.

Ms. Dummett was also issued a uniform traffic citations for careless driving under FL Statute: 316.1925, Crash-Driver Failure to Report Crash under FL Statute: 316.065, Dui-Property Damage/Personal Injury under FL Statue: 316.193(3)(c)1, Crash Leaving the Scene without giving info FL Statue: 316.061 (1), Fail to Display Registration under FL Statue: 320.0605, Battery on a LEO under FL Statute: 784.07.2b

After speaking with the driver of Vehicle 2 of the crash they advised me that she had been driving without one tire and that she had left the scene after colliding with the tractor trailer she continued off the exit ramp at 6th ave and that was when she lost control of her vehicle and came to final rest in the roadway facing northbound.

Video of the traffic stop, roadsides and transport are available through the FHP custodian. The above incident did occur in Palm Beach County, Florida.
