

The incident below was captured on my Mobile Video Recorder and marked as evidence under this case number.

On 12/16/2017, at approximately 1959 hours, I responded 5800 W Glades Rd. (Saks Fifth Avenue) regarding a shoplifting that occurred around 1945 hours. Elizabeth Burke, Loss Prevention Employee for Saks, contacted the police after witnessing a W/F, later identified as Joanna Ziemecka place two pairs of pants in her purse and exit the store without paying.

Upon my arrival, I met with Elizabeth inside the Loss Prevention Office. The following is Elizabeth's account of what transpired. At approximately 1944 hours, Elizabeth observed Joanna via video surveillance shopping in the Contemporary Department which is located on the first floor of the store. After watching Joanna for a few minutes, Elizabeth selected a pair of beige woman's pants off a table, then began walking around the store while folding the pants, and then placed the folded pair of pants in her black purse. Joanna continued walking through the Contemporary Department where she removed a pair of gold woman's pants from a hangar and again placed the folded pants in her purse. Joanna then exited the store through the valet entrance which is located on the east side of the store. Joanna made no attempt to purchase the concealed merchandise before exiting the store. The total cost for both pairs of pants is \$791.80 (\$365 and \$375/plus tax) After passing all points of sale, Elizabeth attempted to stop Joanna but Joanna kept walking towards her vehicle, entered the vehicle, and exited the first floor parking garage. Elizabeth was able to recover one pair of the pants that fell from Joanna's purse as she entered the vehicle. Elizabeth was able to provide the tag for the vehicle, FL tag IRWD41. The vehicle came back to a Nissan SUV registered to Joanna with a West Boca address. A description of Joanna and her vehicle was BOLO'd over the radio by Officer D. Graham, who assisted with the investigation, for officers in the surrounding area. I watched the video surveillance footage with Elizabeth and confirmed



the information provided above. Using the information and picture from the vehicle registration, I was able to confirm the woman I observed on the video surveillance footage was Joanna.

Next, I conducted an investigative search via Accurint for Joanna Maria Ziemecka using the information provided from the vehicle registration. I was able to confirm the address on Joanna's driver's license and locate a current phone number for Joanna. At 2030 hours, I called Joanna (561.504.1776) but there was no answer. I left a message with all of my contact information and for her to call me. At 2044 hours, I was notified by dispatch that Joanna had received my message and called into dispatch. At 2046 hours, I called and spoke with Joanna. Joanna explained to me that she took the pants because they were wrinkled and she wanted to take them home, iron them, and bring them back to the store. I was able to convince Joanna to return to the store.

At approximately 2050 hours, Joanna returned to the store with the second pair of pants. Joanna was escorted back to the Loss Prevention office and read her constitution rights from a pre-printed card provided by the department. Joanna acknowledged she under the rights as I read them to her and did not wish to speak to me. Based on the information provided by Elizabeth and the video surveillance footage I placed Joanna under for Felony Retail Theft under F.S.S. 812.015(2). Joanna was placed into handcuffs that were double locked and checked for tightness. Officer K. Cohen responded to the scene and conducted a search of Joanna before she was placed into my marked patrol vehicle. Joanna was transported to the Boca Raton Police Department for processing and later transported to the Palm Beach County Jail. Prior to leaving, Joanna was issued a trespass warning by Town Center Mall Security.

Elizabeth completed a written witness statement that was later submitted into evidence under this case number. I took photos of both pairs of pants and was provided a copy of the receipt which both were later submitted into evidence under this case number. A copy of the video surveillance footage was requested and will be retrieved on a later date.
