On February 9th, 2018 at approximately 1603 hours, I was dispatched to 3625 S Federal Hwy (Walmart) in reference to a retail theft.

Upon arrival, I made contact with Walmart LPO Frantz Bernard, who advised in a sworn statement that he observed a white female, later identified as Jocelyn Harper (DOB 09/21/86) conceal two women's bras in her backpack. LPO Bernard stated he watched Harper select the two bras from a shelf in the apparel department and then proceed to the stationery aisle. Once in the stationery aisle, LPO Bernard advised Harper took both of the bras and placed them in her blue backpack.

With the merchandise still in her backpack, Harper was seen by LPO Bernard passing all points of sale, failing to pay until she was stopped and detained by him. The total value of the items Harper attempted to steal was \$26.41. All the merchandise was recovered and returned to Walmart. Based on the above information I found that there was probable cause to charge Harper with Petit theft according to FSS: 812.014.2E. Harper was transported to PBCJ due to not having a local address in Palm Beach County.
