

to Jones, her boyfriend of 1 1/2 years, John Dinatale w/m 11/23/1982 arrived at their residence. Jones stated that she was talking on the phone to her mother when John tuned on the television, Jones asked Dinatale to turn the volume down on the television. According to Jones, Dinatale slapped the phone out of her hand, pulling out some of her hair. Jones advised that then both she and Dinatale go to bed. Jones stated that while in bed, Dinatale kicks her in her leg area. Jones advised that that Dinatale swings his arm approximately 5 times striking her in both upper arm areas and bottom lip. Jones advised that Dinatale hitting her was unprovoked.

Jones had apparent injuries to her face. Jones bottom lip was swollen and bleeding. Jones also had blood on her left hand and on her shirt. It should be noted that Dinatale was gone upon my arrival.

Based on my investigation probable cause exist to charge John Dinatale with domestic battery per F.S.S 784.03(1).
