Vehicle pattern was observed was observed by the complainant who submitted a sworn written statement and could identify the driver. The driver (John Greene) was located behind the wheel with the ignition on. The driver side front tire was blown out and the wheel had marks consistent with a wheel that had been driven on.

OBSERVATION OF DRIVER:

Greene had very slow, mumbled, and confused speech. Greene had a hard time keeping his balance while walking. It should be noted that Greene was parked in a parking spot and upon approach, i observed him staring at the same screen on his phone and making no movements for approximately 10 seconds.

DRIVER'S STATEMENTS:

Greene could not advise me when or how he blew his tire out. He also could not tell me how he didnt notice it while driving.

Strong odor of an unidentified alcoholic substance.

Other Observations:

Angle of Onset was 35 Degrees. I observed a lack of convergence in both eyes.

WALK & TURN:

This task was explained and demonstrated to Greene. While demonstrating, Green left the position and stood with his feet side by side. Greene stated he understood and began the task. Greene began with his right foot which was not as instructed. During his first 9 steps, Greene missed heel to toe on steps 4, 5, and 8. Greene turned right very quickly instead of slow deliberate steps. On the returning 9 steps, Greene missed heel to toe on steps 3, 6, and 8. Greene also stepped off the line on step 5.

ONE LEG STAND:

This task was explained and demonstrated to Greene. Green stated he understood and began the task. The task was as follows. Greene chose to stand on his right foot. Green began counting incorrectly and counted in the manner of 1, 2, 3, etc. Instead of 1001, 1002, 1003... as instructed. Greene lost his balance and put his foot down on 21. Greene did not continue the task.

FINGER TO NOSE:

This task was explained and demonstrated to Greene. Green stated he understood and began the task. The task was as follows.

- L1 - Pad of finger to tip of nose.
- R2 - Tip of finger to right nostril.
- L3 - Tip of finger to tip of nose.
- R4 - Pad of finger to rights side of upper lip and searched for nose.
- R5 - Pad of finger to rights side of upper lip and searched for nose.
- L6 - Tip of finger to tip of nose.

*It should be noted that it too approximately 3 seconds after touching his nose for him to take his and down as instructed.

ROMBERG ALPHABET:

This task was explained and demonstrated to Greene. Greene stated he understood and began the task. Greene stated he attended high school but did not finish, He also stated he does know his alphabet. The task was as follows: A, B, C, D, E, F, G, H, I, J, K, LMNOP, Q, R, I, K, LMNOP, X, Y, AND Z. Greene stated "I really screwed that up." Greene attempted to do the task again with his head up and eyes open. It was as follows: A, B, C, D, E, F, G, H, I, J, K, LMNOP, I....and stopped.


