


I was en-route to a residence located at 8923 Jaspers Dr., Boynton Beach, FL 33472, in reference to a domestic dispute. I was advised the male half, John Arwood, had been breaking things in the residence prior to leaving in a 2014 red Toyota Prius (FL Tag# 524NQT). I observed the vehicle traveling South on Jog Rd from Gateway Blvd with an expired tag of 1/15/18. I activated my PBSO lights and sirens and stopped the vehicle in front of the MD Now located at 8899 Boynton Beach Blvd., Boynton Beach, FL 33437.

I approached the driver and requested he provide his driver's license, registration and insurance; however he refused to provide me the documents until he was told why he was being stopped in the first place. I advised John his tag was expired, in which he argued it was valid. I asked him once again to provide his documents, but he continued to question me about the stop. While speaking to John, I observed his knuckles to be bloody, a pocket knife on the front passenger seat, and a 1.5 liter bottle of Jim Beam whiskey on his passenger side floorboard. The seal of the bottle was broken and a quarter of the liquor had been gone. I asked John what caused his knuckles to bleed and what caused the verbal altercation at his residence, but he refused to answer. John appeared coherent and in the right state of mind to understand the questions I was asking. I ordered John to step out of the vehicle for further investigation, in which he refused and started to roll his window up. I took my PBSO issued firearm out of my holster and held it in front of my chest ordering John opened the door, in which he finally did so. John stepped out of the vehicle and was placed in handcuffs, due to the fact that he was hindering my investigation on a lawful traffic stop and the use of force was necessary in order for him to cooperate.

Based on the above facts, I find there to be probable cause to charge, John Arwood, with FSS 843.02, Obstruction. John was cited for the following violations: alcoholic beverage open container (Cit# A9CTHIE), expired tag (Cit# A9CTHHE) and license not carried (Cit# A9CTHGE). John was transported to the Palm Beach County Jail by D/S Gorfido #24739. This case is cleared by arrest.
