On 5/27/17 around 1815 hours, I responded to 3865 Ace Rd W in unincorporated Lake Worth, Palm Beach County Florida 33467, in reference to a domestic battery.

Upon my arrival in front of the residence, I observed a white male, whom I later identified via D.A.V.I.D to be John Beale Jr, fleeing northbound on foot from the back of the residence. I walked up to the front door and made contact with Jaimie Bethel, who identified herself via her Florida Driver's License. Jaimie complained of pain in her leg from being kicked, and she showed me a red mark on the back part of her left thigh. I asked Jaimie what happened and she told me the following: she and her live in boyfriend of three years, John Beale Jr., have been drinking beer throughout the day. It should be noted that Jaimie and John have a relationship that is intimate in nature, and the two have a two year old child in common. She was grilling hamburgers on the back patio, when John came outside and started an argument with her because he was jealous that she could be romantically interested in a roommate. Jaimie said she moved inside trying to get away from John, but he persisted in following her and yelling at her. John pushed Jamie and kicked her in the back part of her left thigh, causing her injury. Jaimie's daughter Gretchen came home and say John battering Jaimie, so she stepped in and tried to stop John. John then Shoved Gretchen. I observed the mark on Jaimie's thigh consistent with this version of events. Jaimie allowed D/ S /Berger to photograph her injury, and she gave me a sworn written statement to the above.

I next interviewed Gretchen Bethel, who identified herself via her Florida Driver's License. Gretchen said she was at the residence visiting her mother with her boyfriend Rupert Wilson. When she arrived at the residence, she observed John kicking and pushing Jaimie. She tried to step in and stop John from attacking her mother, and John pushed her. Gretchen went outside and said she was calling 9-1-1, and John followed her and pushed her again. She then saw John run away on foot. Gretchen gave me a sworn written statement to the above. I observed red marks on Gretchen's neck and chest area consistent with her story.

I next interviewed Rupert Wilson, who identified himself via his Florida Driver's License. Rupert confirmed Jamie and Gretchen's stories, and said he observed John push and kick Jaimie. He then observed John shove Gretchen, follow her outside, shove her again, and run off on foot. Rupert gave me a sworn written statement to the above. It should be noted that all witnesses were kept separate prior to being interviewed, and all gave consistent accounts of what transpired.
