PROBABLE CAUSE

On Tuesday 12/19/2017 at approximately 12:38 AM, and while on patrol I was dispatched to the scene of a wrong way driver. Dispatch advised the driver was traveling north using the southbound lanes. Dispatch also advised that an off-duty officer stopped the vehicle and were waiting on the right shoulder. I arrived to the scene on Interstate 95 (State Road 9) southbound at Belvedere Road. I observed an unmarked law enforcement vehicle with its emergency equipment on. I also observed a blue Chevy SUV facing the wrong direction (Plate# Florida- DLGL98), after running the tag through FCIC/NCIC, I confirmed the vehicle to be a Chevy Blazer, blue in color. I made contact with the subject, who was seating on the driver's side, behind the wheel. As I approached the driver side window I smelled a strong odor of an unknown alcoholic beverage emanating from within the vehicle. I introduced myself and requested the driver to step out of the vehicle. I requested the subject for his driver's license, registration and insurance. The subject started to look for the documents inside his wallet but did not find them, the subject stated he might have left them inside his car. The subject forgot he gave the documents to the off duty officer. While talking to the subject, I smelled the odor of an unknown alcoholic beverage coming from the subject's mouth area. I also observed glassy eyes, flushed red skin on the subjects face, slurred speech and poor balance. The subject had to be reminded to be careful not to fall back and to maintain balance several times. I spoke with the off-duty officer (Ofc. Austyn Kelh) from west Palm Beach PD, he stated he was traveling south on Interstate 95 (State Road 9) when he observed a vehicle traveling north using the south bound lanes, he also notice the vehicle was straddling and swerving, he stated that some vehicle traveling south had to maneuver to avoid collision with the subjects vehicle. Officer Kelh provided a written statement. I read the Miranda rights to the subject, the subject stated he understood his rights and that he wished to continue talking to me. I asked the subject where he was going, the subject state he was not from the area but that he was driving home. I asked the subject if he had any medical conditions and he answered no. I asked the subject if he had something to drink, the subject stated he was coming from a friend's house and had 2 drinks. The subject did not specify what kind of drinks he had. I told the subject I suspected he was driver under the influence of alcohol and that I wanted him to perform the Field Sobriety Exercises to make sure he is not impaired to continue driving. The subject agreed to perform the Field Sobriety Exercises.

FIELD SOBRIETY EXERCISES:

HORIZONTAL NYSTAGMUS: Yes

Equal Tracking from both eyes, equal pupil size, delayed pursuit on the right eye, nystagmus was present at maximum deviation and prior to 45 degrees on both eyes.

Subject had to be reminded several times to not follow the stimuli by moving his head.

WALK AND TURN:

Subject started the exercise too sun, did not follow straight line, used arms for balance, steps were not heel to toe. 18 steps in total.

ONE LEG STAND:

Subject lifted left leg, used arms for balance, swayed, and placed his foot down. The subject did not followed instructions, he finished the exercise after counting to 5.

FINGER TO NOSE:

Subject missed the target (Point of the nose) several times, the subject touched his upper lip instead of his nose.

DEC 19 AM 4:37

Based on my observations and the totality of the circumstances, I placed the subject under arrest for Driving under the influence of alcohol. The arrest was made at 1:26 AM. The subject was placed inside my patrol vehicle and secured with the seatbelt. The subject was transported to County Jail. On arrival I removed the seatbelt from the subject and helped the subject exit my patrol car. Once more, I smelled the strong odor of an unknown alcoholic beverage emanating from inside my vehicle. The subject was placed under observation for 20 minutes at 1:45 AM. The subject did not vomit nor introduced anything inside his mouth during observation. The subject was asked if he was willing to provide a lawful sample of his breath, the subject agreed. The subject blew 0.210 twice. The subject's custody was transferred over to the County Jail staff.






