On the **19** day of **February**, **2018** at **20:27** (Specifically include facts constituting cause for arrest.)

On February 19, 2018 at approximately 20:27 hours I, Officer Ryan Smith, responded to the Gardens Medical Center Emergency Room (ER) located at 3360 PGA Blvd, Palm Beach Gardens, FL 33410.

I was responding to pick up an Officer who had helped transport the subject, John Paraskevas, from the PGA National Resort located at 400 Avenue of the Champions, Palm Beach Gardens, FL 33418. Paraskevas was highly intoxicated and disorderly during the incident that Officer Artola had handled. See Officer Artola's supplement for further information on that incident.

Upon my arrival at Gardens ER, I witnessed Paraskevas laying on a hospital bed being attended by a nurse. As I was leaving a nurse alerted me that Paraskevas was trying to leave the ER without clearance from the Doctor. I observed Paraskevas trying to leave through the restricted area of the hospital, and was then confronted by Officers Leskow, Artola and myself. Paraskevas smelled of an unknown alcoholic beverage and had red glossy eyes. Paraskevas became angry and argumentative inside the main area of the ER that was filled with patients and nurses.

It was a busy night, with all rooms appearing to be full of patients waiting outside of occupied rooms. Paraskevas continuously made threatening gestures toward all the officers, putting his hands up and clenching his fists, and loudly cursing causing a disturbance to all the patients in the ER. Paraskevas continuously disregarded instructions by Officers to go sit on the hospital bed so the nurses could tend to him. Paraskevas stated that he would not sit down and that he would rather go to jail. After numerous times of telling Paraskevas to sit down and him refusing, I placed him in handcuffs for the safety of myself and all other parties in the hospital. His handcuffs were check for fit and double locked, then after he was cleared by the hospital was placed in the rear of my patrol car.
