On December 30, 2016, at approximately 0437hrs, D/S M. Collura conducted a traffic stop at the location of 95TH AVE S and GLADES RD, in unincorporated Boca Raton, FL.

D/S M. Collura was parked at the intersection of 95th Ave S and Glades Rd, facing north, D/S M. Collura observed the following:

A white Cadillac (bearing tag GDDT78) entered the turn lane of Glades rd. to turn South onto 95th Ave S. The Cadillac stopped approximately 50 before the stop bar of the red light. After being stopped for approximately 2 minutes, the White Cadillac then accelerated forward at a high rate of speed to come to an abrupt stop with the front tires approximately 20 feet past the stop bar of the red light. Collura, I approached the driver's side of the Cadillac. Upon approach I observed both windows on the driver's side open. I could smell the odor of an unknown alcoholic beverage coming from inside the vehicle. In the driver's seat I observed a white male, later identified by his Florida Driver's License as John Ferrante. His eyes were watery and he was squinting. When he spoke to me I could smell the odor of an unknown alcoholic beverage coming from his breath. His lips were dry and he had a bluish ring around his mouth on his lips. His speech was slurred and mumbled. I asked if he could place his keys on the dashboard. He fumbled around the passenger's seat, center console, and underneath his person searching for the keys. I asked him to exit the vehicle to complete Standard Field Sobriety Tasks (SFST). As he exited the vehicle he used the door and frame for support. I asked him to walk to the back of his vehicle; he used his vehicle for support. At the back of his vehicle he leaned against the trunk to maintain his balance.

DRIVER'S STATEMENTS:

Post Miranda, he told me he was coming from the "Prime Cigar". After arrest, he became very apologetic.

ODORS:

The odor of an unknown alcoholic beverage from his person and breath.

GENERAL OBSERVATIONS

SPEECH: slurred and mumbled

ATTITUDE: cooperative, hilarious, carefree, polite, sleepy

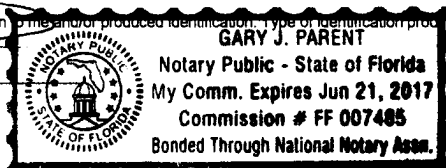

Other Observations:

During this task his body swayed. His eyes were watery and he was squinting. The task was completed on a dry and level surface.

WALK & TURN:

I instructed and demonstrated the Walk and Turn. He acknowledged he understood. During the instructional phase he had a very difficult time standing as instructed and had to step off the line several times. He began to start the task before being instructed to do so. He started the task by taking 8 steps forward. He failed to maintain heel to toe on several steps. He had difficulty walking on the line and stepped off the line numerous times. He had to raise his arms from his side to maintain his balance. He completed the turn incorrectly. He then walked 8 steps back. He failed to maintain heel to toe on almost every step. He stepped off the line several times and had raised his arms from his side for balance. The task was completed on a dry and level surface using the centerline of the roadway.

ONE LEG STAND:

I instructed and demonstrated the One Leg Stand. He acknowledged he understood. His body swayed during the instructional phase. He lifted his right foot off the ground approximately 1 inch and could not keep it off the ground for more than a couple seconds. He raised his arms from his side for balance and almost fell over several times. The task was completed on a dry and level surface.

FINGER TO NOSE:

I instructed and demonstrated the Finger to Nose. He acknowledged he understood. His body swayed during the task. On the first command he placed his finger on the side of his nose. I had to remind him to place his hand back down at his side. On the remaining commands he placed his finger across his nose or touched his mouth first. The task was completed on a dry and level surface.

ROMBERG ALPHABET:

He told me his highest level of education was some college. He had difficulty remembering which college he went to. He stated English was his primary language and knew the English alphabet. His body swayed during the task. He recited the alphabet: a, i, a, b, c, d, e, f, g, h, i, j, k, l, m, n, o, p, q, u, r, x, u, p, h, s, y, p. The task was completed on a dry and level surface.

I instructed the modified Romberg. He acknowledged he understood. His estimate of 30 seconds was approximately 45 seconds. His body swayed during the task while his body was leaning forward. He appeared to have difficulty when counting. The task was completed on a dry and level surface.

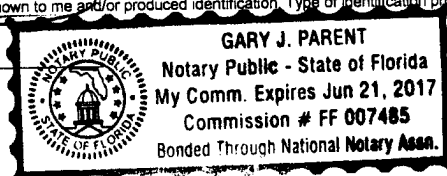

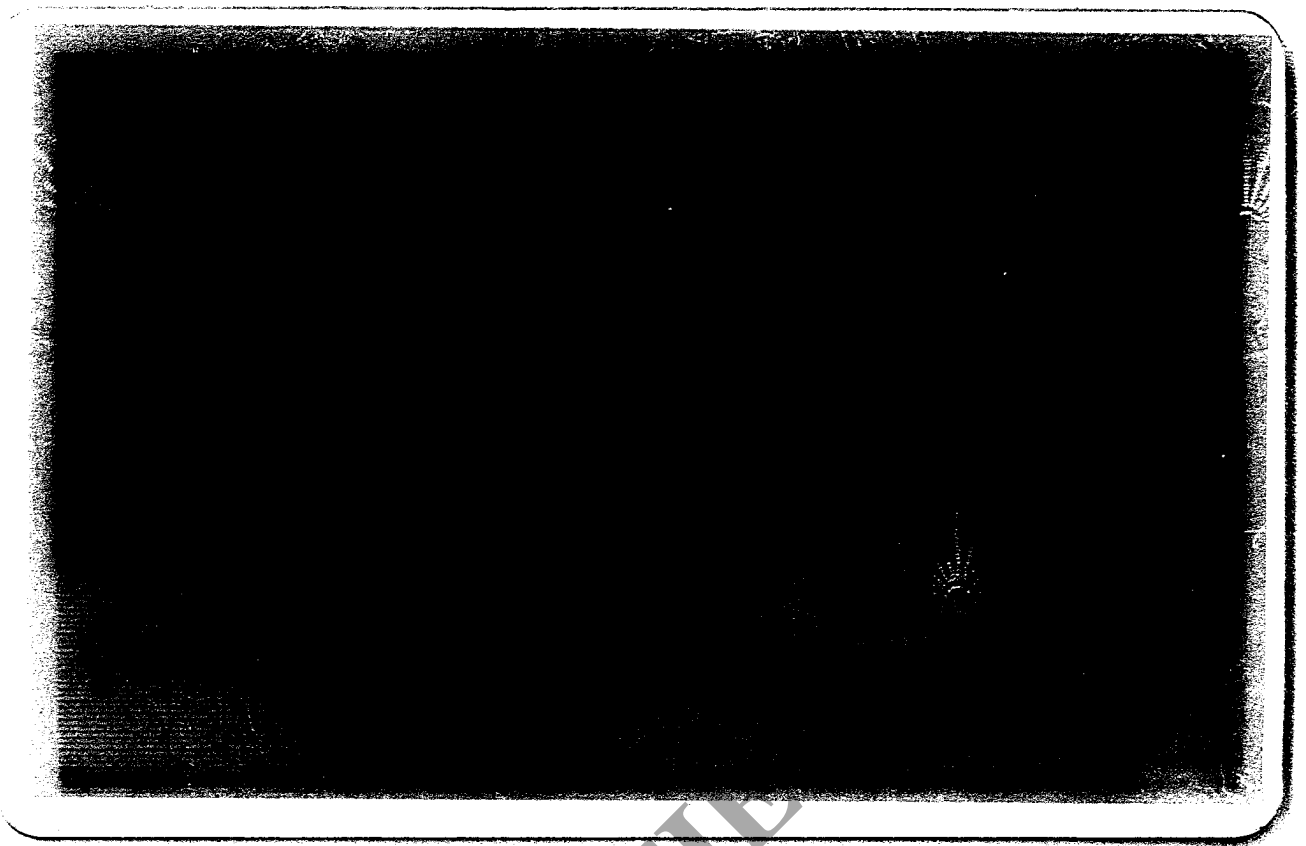
