<p>On December 18, 2017 Officer Van Camp and I initiated a traffic stop at 100 NE 20th St on a silver Volkswagen bearing FL tag 525MLC for an improper left turn at 200 NE 20th St. Before initiating the traffic stop, Officer Van Camp noticed the passenger side door open and a small silver baggie being thrown out of the door. I activated my overhead emergency lights and conducted a traffic stop. It should be noted that the passenger door was open and the silver bag was next to the passenger side door on the ground. The driver had to be ordered back into the car.</p>						
<p>I made contact with the driver who identified himself as W/M Jon Machusko. Jon stated that his windows do not roll down and that is why he jumped out of the car. Ofc Van Camp made contact with the passenger who identified himself as W/M Christopher Minasi. Machusko and Minasi were the only occupants inside of the vehicle. Ofc Van Camp retrieved the silver bag on the ground. Upon retrieving the bag, he noticed the distinct odor of marijuana emanating from the silver bag.</p>						
<p>The driver was ordered out of the vehicle, where he was searched and placed into handcuffs. The passenger was ordered out of the vehicle, where he was searched and placed into handcuffs. A search of the car yielded negative results for more contraband.</p>						
<p>Machusko was read his Constitutional Warnings from a preprinted BRPD card. He advised he understood his rights and stated he would speak to me. Machusko stated he was coming from a friend's house heading home. He noticed the police car behind him so he asked passenger, Minasi, to open the passenger door so he could throw out the bag containing marijuana. Machusko admitted that the marijuana was his and that he told Minasi to open the door and threw the bag out of the door. Machusko stated that Minasi had no knowledge of the marijuana being in the car.</p>



Minasi stated that he was just riding with Machusko to a friend's house. He stated that Machusko told him to open the car door and that Machusko threw the bag outside of the door. Minasi stated that he had no knowledge of the marijuana inside of the car.</p> <p>The green leafy substance inside of the silver bag was tested with a Quikcheck Purple Marijuana field test kit. The green leafy substance turned purple inside of the test kit, testing positive for THC.</p> <p>Machusko was subsequently arrested for Possession of Marijuana under 20 grams pursuant to FSS 893.193(6B) and Tampering with Evidence pursuant to FSS 918.13(1A). Machusko was taken to Boca Raton Police Department Holding Facility for processing. The marijuana weighed 4.2 grams. The silver bag and marijuana were placed into evidence. Machusko was processed and taken to Palm Beach County Jail.</p>
