My department issued BWC was activated. Upon arriving in the area, I observed an unidentified white male walking on the sidewalk at the corner of Mirasol Way and Monte Carlo Drive waiving his arm back and forth in the air. We made contact, he identified himself as Jeffrey L. Saporta (DOB: 11/2/49) and informed me that he trying to get away from his son. My training officer P. Reynolds #320 made contact with a male who was standing by the marque sign at the entrance of Monte Carlo Drive, and identified him via Florida Driver's license as Jonathan S. Saporta (DOB: 9/17/79), Jeffrey's son.

Jeffrey gave the following statement:

Just prior to 911 being dialed, his son Jonathan arrived at the house with his girlfriend. He noticed that he had been drinking. Jeffery said while inside the house, Jonathan tackled him down to the ground and held him down by his arms. I asked Jeffrey if he needed medical attention, to which he answered "no", and refused medical attention. Jeffrey said Jonathan gets violent whenever he drinks too much alcohol. Jeffrey informed me that when he was able to get free from Jonathan, he had to run down the street to get away from him.

While getting a statement from Jeffrey, I saw Jonathan attempting to charge in my direction towards Jeffrey. Ofc. Reynolds was able to prevent Jonathan from coming closer as additional units were responding to the area. Officer A. Huba #425 and Officer A. Luciano #478 later arrived at my location. While briefing Ofc. Huba about the incident Jonathan pulled away from Ofc. Reynolds and ran in our direction. Ofc. Reynolds immediately ran after Jonathan. Ofc. Huba, Ofc. Luciano and I also began to run towards Jonathan. Ofc. Huba could be heard giving Jonathan verbal commands to stop running or he would be "tased". Jonathan was subsequently tased in the back by Ofc. Reynolds. Jeffrey was temporarily placed in the back seat of the marked patrol car for his safety. Jonathan was immediately placed into handcuffs by Ofc. Huba and Ofc. Luciano. While being handcuffed, Jonathan began to yell out towards Jeffrey, "Where is He!" "I Hate him!" "I'm gonna kill him!" Jonathan was placed in a seated position until Palm Beach Gardens Fire Recued arrived. While waiting for Fire Rescue, Jonathan re-directed his anger towards me using racial comments and calling me a "Nigger Cop!" Jonathan continued using the racial language until he was placed in the rear of the Fire Rescue truck. Jonathan was transported the Palm Beach Gardens Hospital for further observation, Palm Beach Gardens Fire Rescue Run#: 17009304.

Jeffrey was escorted to his home where he continued his statement. Jeffrey said when his wife Adrienne Saporta (DOB:1/17/49) announced the arrival of Jonathan and his girlfriend Marial Rosewasser (DOB: 11/26/81), he said Jonathan had "that look" in his eyes. When Jeffrey told Adrienne that he wanted to talk to her alone, Jonathan ran behind him (while still in the living room) and tackled him down to the floor, holding him there. When Jeffrey asked Jonathan why he was "doing this", Jonathan yelled, "Because I love you!" Jeffrey said upon being able to get away, Jonathan began to chase him outside of the house and down the street.

Adrienne Saporta (DOB: 1/17/49) and gave the following sworn statement.

Adrienne said she announced Jonathan and Marial's arrival at the house, and she and Jeffrey met them in the driveway. When Jeffrey greeted Jonathan, she could tell he (Jonathan) had been drinking. Adrienne said Jeffrey mentioned wanting to talk privately to Marial as they were standing in the driveway. Adrienne went into the home, and Jeffery followed. As Jeffrey walked into the living room, Jonathan ran into the house after Jeffrey. Jonathan knocked Jeffrey to the ground and held him there by the neck. When Jeffrey was able to get up, he ran outside, and Jonathan chased him down the street. Adrienne stated when Jonathan knocked Jeffrey to the ground, she called 911. When Jonathan began to chase Jeffrey down the street, she lost sight of them because

she wasn't able to keep up.

Officer Reynolds gave the following information regarding his initial contact with Jonathan, as follows:

"The son who was later identified as the defendant, Jonathan Saporta showed signs of intoxication. He was slurring his words and unsteady on his feet. After obtaining his license Jonathan took several quick steps towards his father's direction stating, "I'm gonna fuck him up", with his fists balled up. With minimal hand control I was able to stop Jonathan and temporarily divert his attention. Jonathan subsequently did this a second time and again I used minimal hand control to stop him. Jonathan advised his father used to beat him as a kid. A few moments later he balled his fist again and took off running towards his father. I attempted to grab Jonathan by his right arm, in an effort to take him to the ground, but he was very sweaty and slipped from my grasp." Please see Officer Reynolds supplement for further.

After completing my investigation, Jonathan was charged with Battery on a Person 65 years or older (Domestic Related), per F.S.S. 784.08(2)(C) and Resisting an Officer without Violence, per F.S.S. 843.02. Jonathan was medically cleared from Palm Beach Gardens Hospital and later transported to the Palm Beach County Sheriff's Office without incident.
