

I was at the above address at 1102 hours for the same incident reference incident number 17205734.</p> <p>During the previous incident the front door to 224 Timberwalk Trail was open, Officer Schwes 369 and I approached the front door Jonathan Turner Norcia (wm 06/23/1970) was standing in the living room. I announced my presence Norcia started to walk towards me at a quick pace. Norcia was verbal abusive and shouted "Fuck You" to both Officers. I ordered three times Norcia to stop walking towards me and to keep his hands where I could see them. Upon contact I immediately detected a strong presence of an unknown alcoholic substance coming from him. Norcia admitted to drinking alcohol and he has a substance abuse problem. Norcia went through several emotional changes and was brought to tears several times during our discussion. Norcia was able to be calmed down by the Officers and he stated he did not want to harm himself or others. Michele Lynn Zalinger (wf 12/08/1970) who is Norcia's girlfriend was at the residence and was advised to notify the police immediately if Norcia has another episode. As a result from this incident Norcia did not meet the criteria at the time for an involuntary Law Enforcement Baker Act.</p> <p>While enroute to another call, Northcom dispatched Officer Chad Smith to 224 Timberwalk Trail for another verbal disturbance. I redirected to the call and made myself the primary unit. Upon my and Officer Smith's arrival the front door was closed. I knocked on the door several times and Zalinger answered the door. Norcia was located sitting in the living room. Zalinger uttered Norcia stated he thinks Police Officers are in his attic. Zalinger also stated he was not taking his medication and he was yelling at the neighbors again after officers left the first time.</p> <p>In compound with the previous incident, Zalinger's above statements, and the level</p>



<p>Norcia's level of intoxication I decided to place Norcia under an involuntary Law Enforcement Baker Act. I ordered Norcia to exit the residence and he refused. I ordered Norcia again to exit the residence and he refused again. I grabbed Norcia's left wrist and he tensed up and pulled away from my grip. I grabbed his left wrist again and he tensed up again and refused my orders to stand up. Norcia was shouting and stated he was not going anywhere. Officer Smith placed a handcuff on his left wrist. I was gaining control of Norcia's right wrist in order to place an additional handcuff on him. Norcia continued to brace and pull away from both Officers. While attempting to place the second handcuff onto Norcia and to take Norcia to the ground, Officer Smith was shoved into a China Cabinet in the living room after Norcia swung his left arm backwards. Norcia continued to resist Officer Smith and me by swinging his shoulders backwards making contact with both officers. Officer Smith and I then placed Norcia faced down onto a couch in the living room. Norcia continued to tense his body and scream verbal obscenities. The second handcuff was placed onto Norcia's right wrist Officer Smith and I escorted Norcia outside to my patrol car.</p> <p>During the escort to my patrol car Norcia continued to be verbally abusive and was kicking Officer Smith and me. Once at the patrol car I attempted to conduct a more thorough search of Norcia. During the search Norcia kicked my legs again. After the search was completed Officer Smith and I attempted to place Norcia into my patrol car. At the rear passenger door Norica turned to Officer Smith and me and braced himself again and would not obey our orders to get inside. Officer Smith removed his taser and order to comply or he would be tased. I remained hands on with Norcia at the door and Officer Smith went along to rear driver side door. There Officer Smith opened the door and pulled Norcia into the rear seat.</p> <p>Once, in my patrol vehicle Norcia went through several more emotional swings. Norcia again was brought to tears. Sergeant Frank 213 arrived on scene Officer Smith and I explained the situation. After several moments Norcia again became aggressive in nature and yelled "Fuck You" multiple times. While in transport to the Jupiter Police Department Norcia again went through several emotional swings and at one point called me a "carrot topped fuck". Once at the Jupiter Police Department, Norica was escorted by multiple officers to the holding cell. Upon entry of the holding cell, I was holding Norcia's right arm when he thrust his elbow backwards into my chest. While speaking to Sergeant Frank in the holding cell Norica openly stated "Face me man to man take off your badge and I'll beat your ass"! Sergeant Frank advised Norcia that was a verbal threat against an officer. I witnessed Norcia state "You made my enemy list". I also witnessed Norcia sitting on the cell bench crying yet again. Norica continued to yell at the top of his lungs and stated multiple times "Let's Go!!!". Norcia kicked the holding cell repetitively and was calling me a "faggot" over and over.</p>




P R O B A B L E  C A U S E	<p>Officers remained on scene and obtained a sworn written witness statement from Zalinger. In her statement she said Norcia suffers from manic bipolar disorder. He was treated three weeks ago and placed on Halidol and Lithium for his condition. Zalinger stated he thinks cops are in the attic of the residence. He was two and half years sober. His roommate did not pay his portion of the rent and she left to go on vacation. While she was on vacation Norcia relapsed and overdosed. Zalinger requested to have Norcia baker acted, but the Doctor said he did not meet the criteria. Norcia has been manic since. Today Norcia and Zalinger were moving him out. Zalinger stated Norcia became very angry and upset. Zalinger stated Norcia drank and got verbally abusive to the neighbors. Zalinger stated officers came and Norcia started to relax. Norcia became angry again, officers were called again. Zalinger stated Officers returned and Norcia resisted. Zalinger requested Norcia to be Baker Acted.</p>							
	<p>As a result of my above investigation I find probable cause that Jonathan Turner Norcia did knowingly and willfully resist, obstruct or oppose Officer Schneider, a law enforcement officer of the Jupiter Police Department in the execution of a legal process or in the lawful execution of a legal duty, by offering or doing violence to the person of such officer, contrary to Florida Statute 843.01. (3DEG FEL) (LEVEL 5)</p>							
	<p>While in the holding cell Norcia remarks about "Taking my badge off and he'll beating my ass" and "You made my enemy list" I find probable cause that Norcia did unlawfully harm or threaten unlawful harm to Officer Schneider, a public servant of the Jupiter Police Department, or did unlawfully harm or threaten unlawful harm to the public servant's immediate family, or to any other person with whose welfare the public servant is interested in, with the intent or purpose to influence the performance of any act or omission which the said Jonathan Turner Norcia believes to be, or that the said public servant represents as being, within the official discretion of the said public servant, in violation of a public duty, or in the performance of a public duty, contrary to Florida Statute 838.021(3)(A).
