

On the <u>20</u> day of <u>June</u> , <u>2017</u> at <u>19:06</u> (Specifically include facts constituting cause for arrest.)								
<p>On Tuesday June 20, 2017, at 1729 hours I was dispatched to 3030 South Ocean Blvd as backup for Deputy L. Moral of the Palm Beach Sheriff's Office. Deputy Moral was with a W/M, later identified as Jonathon W. Spence (DOB 02/21/1985), who passed out on the grass across the street from 3030 S Ocean Blvd.</p> <p>Upon my arrival, Deputy Moral stated that he got a call that Spence was kicking and throwing sand at people on the beach. He started searching the area and found Spence just south of Lake Worth Beach, along South Ocean Blvd, lying in the grass and not moving. Deputy Moral said when he made contact with him; Spence began cursing at him and became aggressive.</p> <p>I noticed Spence sitting on the grass area. When I asked him if he had an ID, Spence said no and stared to yell and curse at us. I asked Spence if he lived in the area and he stated that he was homeless. Spence then started getting aggressive moving around a lot. We told Spence several time to sit down, but he became angry and said "no" and "go fuck yourself!" Spence then pulled his shirt off and balled his fist, as if he was going to fight us. At that time, Deputy Joseph and I grabbed Spence by the arms and took him to the ground. Spence actively resisted our efforts to control him. I grabbed his right hand and put it behind his back as Deputy Joseph tried to get Spence's left hand out from under his chest. Spence refused to comply with our verbal commands to put his hand behind his back and resisted our efforts to handcuff him. Deputy Moral got his TASER out and delivered a drive stun to Spence's left shoulder. We were then able to get Spence's hand from under his chest and I was able to handcuff him. However, Spence was still resisting and he kicked Deputy Joseph in the chest with his feet. Spence eventually calmed down and sat on the grass until Palm Beach Fire Rescue arrived. When Lt. Weber (PBFR) started asking Spence questions, Spence again became aggressive and combative, so we held him down until a medication was delivered to calm down. Spence was transported to JFK Medical Center.</p>
