On the 7 day of June, 2018 at 13:36 (Specifically include facts constituting cause for arrest)

On 06/07/2018, at approximately 1135 hours, I arrested and charged Jason Altomare (W/M DOB 07/21/1984) with Domestic Violence - Aggravated Battery with a Deadly Weapon Pursuant to F.S.S. 784. 045. The details are as follows:

On 06/07/2018, at approximately 0758 hours, I was dispatched to the Palm Beach Hotel (235 Sunrise Ave) in reference to a dispute in progress. Palm Beach Hotel front desk employee Cayla advised PBPB communications personnel that two males were intoxicated and fighting. Upon my arrival I observed a white male wearing a long sleeve black shirt and beige slacks walking westbound from 235 Sunrise Ave.

The male later identified as Jordan Altomare (W/M DOB 07/21/1984) was covered in blood. There was fresh wet blood on his shirt, slacks, and checkered pattern shoes. J. Altomare was confrontational, had bloodshot eyes, and had an odor of an unknown alcoholic beverage emitting off his person. J. Altomare was placed in handcuffs, which were double locked and checked for tightness. At this time, Altomare invoked his right to remain silent.

I then made contact with The Palm Beach Hotel employee (maintenance) Richard Dziedzic who stated that he heard furniture breaking and that two men were fighting and screaming inside Apt. 2217. Dziedzic knocked on the door and the confrontation from inside the room stopped. Dziedzic heard one of the men say "now we are in trouble, maintenance is here". J. Altomare opened the door and walked passed Dziedzic. Dziedzic stated that J. Altomare was covered in blood. Dziedzic told J. Altomare that the Police were coming and J. Altomare stated, "You can't stop me". Dziedzic observed the interior of the room from the hallway and stated to me that the room was a mess.

I then made contact with the other male in Apt. 2217. I knocked on the door and Francis Altomare (W/M DOB 01/30/1982) opened the door. F. Altomare was covered in blood and was

bleeding profusely from his right hand and right shoulder. His shirt was drenched in blood. There was a large gash on the top of his hand between his index finger and thumb, which appeared to be a defensive wound. There was a large gash / skin flap on his right shoulder.

The apartment was in total disarray with broken glass items thrown about and pools of blood against the left wall as you enter the apartment. The glass table inside the apartment (rectangle shape table with rounded edges) had a large section broken in pieces. The pieces were laying around pools and smears of blood on the wood floor. The table stand was also upright/ vertical against the wall as if someone threw it against the wall. A thick glass table lamp had been broken and the pieces were found in an around pools of blood. It should be noted that the disarray appeared to only be in the common area and not in the bedroom.



After J. Altomare left the scene, F. Altomare was left alone in the apartment. In viewing the interior of the apartment, there were bloody towels on the floor. There were smears of blood on the floor and walls possibly indicative of F. Altomare attempting to clean up the scene.

F. Altomare was transported to Good Samaritan Hospital for the injuries he sustained. Before he was transported to the hospital, F. Altomare gave verbal consent for PBPD to enter his apartment. It should be noted that, F. Altomare was renting the apartment listed above.

F. Altomare stated that he and his brother J. Altomare were out all night consuming alcoholic beverages. F. Altomare stated that when they returned home, J. Altomare started a verbal argument that escalated into a physical altercation. F. Altomare stated that J. Altomare "threw me through a glass table". F. Altomare goes on to say that, he "just wanted to protect his brother from himself".

PBPD Crime Scene manager Minchak responded to the scene as well as Det. Menniti. Further inspection of the scene revealed an approximately 12 inch kitchen knife was discovered in a top kitchen drawer. The knife was wet with what appeared to be blood and water and seemed to have been rinsed. I asked F. Altomare about the knife which he stated he did not know anything about it and refused to answer any more questions. F. Altomare stated that he did not want to incriminate himself or his brother. F. Altomare refused to sign any witness statements.

Due to the above facts, I believe I have probable cause to arrest and charge J. Altomare with Domestic Violence - Aggravated Battery with a Deadly Weapon pursuant to F.S.S 784.045.
