

In the city of Boynton Beach, within the county of Palm Beach, I, Officer D. Whitefield, was dispatched to 125 SE 8th Ave in reference to an intoxicated male. According to the 911 caller, an unknown male, later identified as w/m Jordan Osterhout, was banging on his front door. The caller advised that he did not know who Osterhout was and that he was awoken by him after he started banging on his door and trying to use his keys to get inside.

Upon my arrival, I observed Osterhout standing on the porch of 125 SE 8th Ave attempting to unlock the front door with his keys. Osterhout was visibly intoxicated and had just been given a ride home by law enforcement from a local restaurant (Two Georges), which is located at 728 Casa Loma Blvd. Osterhout was cut off by the bartenders at Two Georges due to him being too intoxicated and disruptive and he was given a ride to his house which is located at 141 SE 8th Ave. After being dropped off at his house, Osterhout wandered four houses down until he ended up at the front door of 125 SE 8th Ave. Osterhout insisted that the house located at 125 SE 8th Ave was his residence, however when we asked him what his address was he stated 141 SE 8th Ave.

Osterhout was clearly intoxicated; he was slurring his speech, his eyes were bloodshot, and had a hard time standing. Osterhout admitted that he had been drinking liquor all day. He was clearly causing a disturbance in the neighborhood just as he had caused a disturbance earlier at Two Georges. Based on the aforementioned, I find probable cause to charge Osterhout with one count of Disorderly Intoxication in violation of F.S.S. 856.011. Osterhout was arrested and transported to BBPD for processing where he repeatedly banged on the doors and yelled calling officers "cock suckers" and "mother fuckers" and stating that he couldn't "wait to ruin" us. After, Osterhout was transported to PBCJ without incident.
