

On the above stated date and time I, [REDACTED] participated in a prostitution operation at the Marathon Gas Station 3639 S. Military Trail, City of Greenacres, Palm Beach County, Florida, due to increased complaints of street level prostitution within the City of Greenacres. [REDACTED] were posing as prostitutes in various locations throughout the city. The locations were chosen due to the citizen's complaints.

Deputy Sheriff I. Campbell #7452 and Deputy Sheriff Guyden were some of the "Decoys" posing as a prostitutes at the Marathon Gas Station. [REDACTED] was approached by two males later identified as W/M Julio Trujillo-Santizo 10-20-92 and W/M Jose F Escobar Reyes 10-20-16. Julio was driving a 4 door white Honda Accord bearing Florida tag 495RXW and Jose was in the front passenger seat.

Upon Julio making contact with [REDACTED] he pulled into the gas station and flagged her over. Julio asked her if she was working? and she replied yes. Julio asked her how much?, and she asked for what? Julio said everything. [REDACTED] asked sex and oral and Julio said yes. [REDACTED] asked for both of them and both the passenger and driver said yes. [REDACTED] said \$20.00 each and both the passenger and driver nodded their head and agreed. Front passenger Jose was asked if he wanted [REDACTED] or [REDACTED] and he said [REDACTED]. The predetermined signal was given and the arrest team responded from a concealed location. [REDACTED] stopped the defendant and took him into custody without incident. The defendant was transported to the PBSO staging area by me [REDACTED], where they were turned over to PBSO Corrections Deputies for processing and later to be transported to the Palm Beach County Jail. Julio's vehicle was left at 3645 S. Military Trail, Greenacres, FL 33463 per his request.

[REDACTED] of the transaction was captured by [REDACTED] who was conducting surveillance from a concealed location. The [REDACTED] of the transaction was packaged and turned into Evidence by [REDACTED]

Based on the above stated facts, probable cause exists to arrest and charge Julio Trujillo-Santizo with Offer to Commit Prostitution pursuant to F.S.S 796.07 (2)(F).
