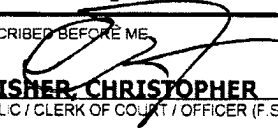
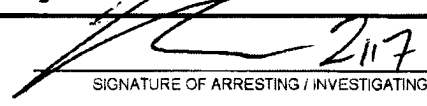

P R O B A B L E	On Friday, June 7, 2019, at approximately 2339 hours, I was dispatched to 114 S Narcissus Ave., Camelot, in reference to an armed disturbance. WPBPD dispatch advised of an older Hispanic male in a dark Lexus SUV who displayed a firearm at the caller. While responding on scene, Ofc. Harrel ID#1637 advised he located the complainant and suspect in the parking lot at the above location and proceeded to detain the suspect without incident.								
	Upon my arrival on scene, I proceeded to make contact with the victim, b/m Robert Chang (03/19/1974), who stated the following:								
	Chang is a parking boot operator who was working at the above location. Chang noticed a black Lexus SUV which was committing a parking violation and proceeded to boot the vehicle, when the owner of the vehicle, later identified as w/m Jose Vila Lago (07/17/1944), made contact with Chang. Chang advised that Vila Lago was able to pay the \$20 fine, and the boot was promptly removed. As Vila Lago was getting ready to leave, Chang advised Vila Lago began to yell at him, however Chang advised it was in a different language and he was unable to understand what Vila Lago was saying. Chang stated Vila Lago proceeded to reach into his right front pocket and pulled out what appeared to be a medium sized, dark in color handgun for the purpose of briefly displaying it. Vila Lago again proceeded to yell at Chang while holding the firearm and placed the firearm back into his pocket. Chang advised, although he was again unable to understand what language Vila Lago was yelling in, Vila Lago never pointed the firearm at Chang and only withdrew it from his pocket.								
	Due to Vila Lago only being able to speak spanish, and the present language barrier, I made contact with him in order to clarify what occurred. After the scene was secure and CSI responded on scene to recover the firearm, Vila Lago was read his Miranda Rights in Spanish, at which point he stated the following:

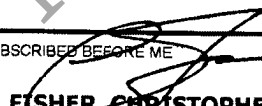
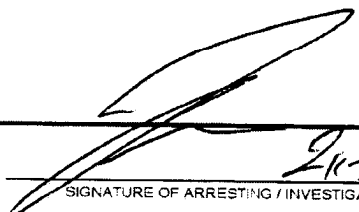

He did not understand why Chang had booted his vehicle and was upset that he had to pay the fine for seemingly no reason. Vila Lago admitted that he did argue with Chang and was upset, but denied ever displaying his firearm. It should be noted that I was communicating with Vila Lago solely in Spanish. I asked Vila Lago how Chang knew he was in possession of a firearm if he never displayed it, to which he replied "I told him I had one in my pocket". I then asked Vila Lago how Chang was supposed to understand what he told him to which he stated that he did not know. Vila Lago advised he typically only carries the firearm in his pocket, however sometime during the exchange, he grabbed the firearm and placed it in his pocket. It should be noted Ofc. Harrel advised me he observed a dark colored handgun (Baretta .380, SN D555294) in plain sight within the black Lexus SUV immediately upon making contact with Vila Lago. It should also be noted Vila Lago was in possession of a valid CCF permit.

I made contact with w/f Yaima Vaez (09/27/1979) and w/m Jose Garcia (05/11/1965) who advised they were on scene when the altercation occurred, however only heard Vila Lago and Chang arguing, but did not observe anything further.

Based on the victims statement, Vila Lago was in possession of a firearm in Chang's presence and exhibited said firearm in a careless and angry manner, not necessary in self-defense, therefore I find probable cause to charge Vila Lago with (1) count of improper exhibition of a firearm pursuant to FSS 790.10. I handcuffed Vila Lago, double locked and checked for proper fit and placed him in the rear of my patrol vehicle. Vila Lago was subsequently transported to the Palm Beach County Jail.

My BWC was active on scene.
