


ground with a closed fist.

As I got closer, Josef was letting the W/F later identified as Jordan McLaughlin off of the ground. I immediately put Josef in handcuffs and advised that he was detained due to the fact that I saw him strike Jordan with his left hand while holding her down with his right hand. The battery occurred in the front driveway of 969 NW 8th Street. After I separated both parties I spoke with Josef. I introduced myself to Josef and read him his Constitutional rights from my pre printed Constitutional Warning card. Josef stated he understood his rights and was willing to speak with me. According to Josef, he has been dating Jordan for approximately 1 year in a relationship that was intimate. Josef explained that he got into a physical argument with Jordan because he was not giving her enough attention at the party. Josef advised the argument took place in the driveway of the aforementioned address. Josef explained while arguing in the driveway with Jordan he threw her to the ground because he was upset and wanted her to listen to him.

Next, I met with Jordan. It was obvious that she was afraid and upset. Jordan had red marks on her left shoulder and neck area. I also observed Jordan's lower lip to be busted. According to Jordan, Josef and her were in a verbal argument and he never hit her. I asked Jordan why she was on the ground and she stated, "I fell". During my investigation Jordan was making irrational statements stating that Josef would never hurt her. I asked Jordan to complete a statement and she refused and stated, "It was an accident". I asked Jordan what was an accident and she stood there puzzled. Jordan no longer wanted to speak to me in regards to this incident.

I then met with W/M Charles Mayes, who witnessed and heard the commotion from inside his residence of 969 NW 8th Street. According to Mayes, he was inside watching TV when all of a sudden he heard two people screaming at the front door. Charles stated he looked out the window and saw a young man and young woman screaming and arguing. Charles advised the man was slapping the woman and trying to put her into a headlock position. Charles explained the woman was trying to defend herself. Charles stated he then saw BRPD run on scene.

Based on my investigation, I have determined that Josef Malec actually and intentionally struck his girlfriend with a close and open hand, against her will contrary to F.S.S. 784.03(1a1). I placed Josef under arrest and transported him to BRPD where he was processed and transported to Palm Beach County Jail.

Written statements were obtained from Charles which was placed into BRPD evidence. Photographs of Jordan's left shoulder and neck area were taken on scene and were placed into BRPD evidence. I provided Jordan with a Domestic Violence pamphlet.
