<p>On Wednesday, August 16th, 2017 at approximately 2411 hours, I was conducting traffic enforcement on Military Trail and Dakota Blvd., Jupiter. At this time, I observed a white, four door Nissan bearing FL tag#DTJN89 traveling south on Military Trail, from Dakota Blvd in the center lane. I was in my marked patrol vehicle unit #1405, parked in the median facing northbound. Using my in car Radar's front antenna, I measured the vehicles speed at 65 MPH. I turned on to Military Trail and traveled South behind the vehicle, while it maintained the speed of 65 MPH in a 45 Mph zone. I activated my emergency lights and stopped the vehicle just south of Fredericks Small Rd, on Military Trail for F.S.S. 316.189(1) Max Speed/ Municipal.</p> <p>I made contact with the driver, W/F Josefia C. Magagnoli 6/24/99 and identified myself as Officer Morgan with the Jupiter Police Department. I asked Magagnoli for her driver's license, registration and insurance. Magagnoli was unable to locate her driver's license, so I informed her that I would look it up. I also informed her that if she found it, that she should hand it to Officer Fandry. I then went back to my vehicle to issue a citation and to look up her license. Officer Fandry signaled me, so that I would come back to the vehicle and stated that Magagnoli told him that she had Hash oil in her purse. I asked Magagnoli to exit the vehicle and if I could search her vehicle. Magagnoli stated, "Yes, go ahead". I had Magagnoli stand by on the curb, with Officer Fandry, while I searched the driver's side of her vehicle. During this time I located a clear container in her brown purse. The clear, round container had Hashish oil/paste, inside of it. I also located another round multi-colored rubber container with red Hashish oil in side. Both substances tested positive for THC, using the Marijuana Quick Test Kit.</p> <p>Next, checked the armrest compartment and located a brownie in a clear plastic bag that had an odor of Marijuana. The brownie also tested positive for THC, using the Marijuana Quick Test Kit. Next to the brownie was a clear glass smoking device with Hash</p>

oil residue. A search of the rest of the vehicle yielded negative results for any other contraband or illegal substances. Officer Magagnoli was read her Miranda rights by Officer Fandry, to which she acknowledged and understood. I asked Magagnoli if the Hashish oil was hers and if it contained THC, she replied, "Yes". I then asked her if the brownie containing Marijuana was hers and she stated, "I did not know it was in there". All of the related evidence was seized and secured in my vehicle.

Based on my investigation, the suspect's statements and the evidence, I believe there this probable cause to charge Josefia C. Magagnoli with F.S.S. 893.13(6)(A) DRUGS - CONTROLLED SUBST W/O PRESCRIPTION (INCL MARIJUANA) , F.S.S. 893.13(6)(B) DRUGS - POSSESS MARIJUANA NOT MORE THAN 20 GRAMS and F.S.S. 893.147 DRUGS - POSSESSION/USE DRUG PARAPHERNALIA.

Magagnoli was taken into custody and placed in handcuffs, which were double locked and checked for proper spacing. Magagnoli was transported to the Jupiter Police Department Holding Facility to complete the appropriate paperwork. Magagnoli was searched by Officer Raleigh while at the Jupiter Police Department Holding, which yielded negative results for any contraband. Upon completion, Magagnoli was transported to the Palm Beach County Jail for booking procedures. Magagnoli vehicle was turned over to her boyfriend, Ivan Piccioni per her request. 5.04 grams of Hashish oil was in the multi-colored rubber container, 11.81 grams of Hashish oil/paste was inside of the clear, round container and the brownie was weighed at 20.47 grams. All related evidence was submitted into the Jupiter Police Department Evidence Facility.


