# D.U.I. PROBABLE CAUSE AFFIDAVIT

## PERSONAL CONTACT

**DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)**  
On the aforementioned date and time, I was stationary, facing south, conducting traffic enforcement on S.R. 811 (S Alt A1A) in the Town of Jupiter, Palm Beach County, FL. I was driving a fully-marked Jupiter Police Department patrol vehicle (vehicle 1425), was wearing a JPD issued uniform clearly identifying myself as a Police Officer, and was wearing my department-issued Axon body camera. I observed a silver 2012 Infiniti G37 bearing FL tag # Y78QPZ traveling southbound on S.R. 811 at a speed which I believed to be in excess of the posted 50 MPH speed limit. I activated my Raptor RP-1, vehicle-mounted, radar unit in stationary mode and received a digital speed readout of 68 MPH. I also noted the audio doppler tone was clear and consistent with a vehicle traveling at the aforementioned speed. As the vehicle passed the passenger side of my patrol vehicle, the audio doppler tone as well as the digital speed readout ceased, indicating that the vehicle had traveled outside of my radar unit's operational range. I maintained constant visual contact with the vehicle and began following it to conduct a traffic stop. While following, I observed the vehicle (traveling in the center southbound lane) swerving within its lane as it neared the intersection at W Frederick Small Rd. I conducted a traffic stop on the vehicle and identified the driver to be Joseph Santamaria (w/m; 10/01/1962) by his valid Florida driver license.

### OBSERVATION OF DRIVER:

Upon initial contact with Santamaria, I observed he had bloodshot, glassy eyes. I noted the odor of an unknown alcoholic beverage on his person, which intensified as he spoke. The odor of alcohol was apparent from the time I initially approached the driver side window. I asked Santamaria to provide his driver license, registration, and proof of insurance for the vehicle. Santamaria provided me with his driver license and registration but appeared to have forgotten to provide me with the insurance card and had to be reminded. As Santamaria was speaking to me, I noted that his speech was slurred, at times. When Santamaria exited his vehicle, it appeared as if he was having difficulty walking in a straight line back to my patrol vehicle, as he favored his left side and began walking more to the left than directly back to my patrol vehicle.

### DRIVER'S STATEMENTS:

Santamaria advised he was coming from a party at a friend's residence in Jonathan's Landing (community in Jupiter) where he consumed a couple alcoholic beverages prior to him leaving. Santamaria estimated that he consumed 3 drinks over the course of 4 hours. He further advised that he ate at the party (several appetizers) and stated he was at the party from 1900 - 2200 hours.

### ODORS:

Odor of unknown alcoholic beverage, which intensified as Santamaria spoke.



**WALK & TURN**

During the Instructions Stage, it appeared as if Santamaria lost his balance, to the right, as he took his right foot off the line and stood with both his feet side-by-side for the remainder of the Instructions Stage. While walking, Santamaria failed to count each step out loud throughout the entire exercise. On steps 3 and 9, he stepped off the line, to the right. Santamaria missed heel-to-toe on step 5. Santamaria took a total of 9 steps. Santamaria turned improperly, by taking small steps with both his feet to turn around. After turning, Santamaria lost his balance and stepped completely off the line, to his left. Santamaria stepped off the line, to the left, on step 1 and stated "are you kidding me? This is fucking retarded." Santamaria missed heel-to-toe on steps 4, 5, 6, 7, 8, and 9. Throughout the exercise, Santamaria's upper body would sway from side to side intermittently and he would periodically raise his arms more than 6 inches from his side for balance.

**ONE LEG STAND:**

Santamaria raised his right leg off the ground, did not count out loud, and placed his foot down 4 times in an approximate 10 second period. Before placing his foot on the ground the fourth time, Santamaria appeared to lose his balance to the left, as he moved his upper body to the left. At this time, Santamaria advised he forgot what "it was to." I advised him it was until I told him to stop and he asked me the same question twice with both his feet on the ground. Santamaria raised his right foot off the ground again and began counting from "one" and counted to "seven" before the exercise was completed. He placed his foot on the ground again several times during this period.

**FINGER TO NOSE:**

On the first call of left, Santamaria appropriately touched his finger to his nose but did not return his hand to his side. On the first call of right, Santamaria touched the middle of his finger to the tip of his nose and did not return his hand to his side. On the second call of left, he appropriately touched his finger to his nose but did not return his hand to his side. On the second call of right, Santamaria again touched the middle of his finger to the tip of his nose and did not return his hand to his side. On the final call of right, Santamaria lifted his right finger off of his nose, and placed it right back on the tip of his nose, touching the tip of his nose with the middle of his right finger. Santamaria appropriately touched his finger to his nose on the final call of left but did not return his hand to his side.


