VICTIM DONNA KING contacted the Boynton Beach Police Department to report a theft. Ofc. Passaro was dispatched and responded to 26 Vista Del Rio, Boynton Beach, Palm Beach County, FL where he met with VICTIM KING. At that time she reported approximately two weeks prior, she noticed all of her jewelry was missing from a jewelry box which had been placed atop her dresser in her bedroom. VICTIM KING indicated she had suspected her daughter's live-in boyfriend, DEFENDANT JOSEPH DANAHOO JR of the unlawful taking of her jewelry and when confronted, she learned he had pawned some of the jewelry at Fasset Cash Pawn, 3934 Hypoluxo Road, Boynton Beach, FL.


On 11/23/17, she recovered some of the stolen jewelry with the assistance of DEFENDANT DANAHOO'S mother, WITNESS JULIE RUSSELL who had agreed to get the items out of pawn if VICTIM KING agreed not to report the incident to law enforcement. Upon inspecting the recovered jewelry, VICTIM KING noticed multiple pieces of jewelry still remained at large prompting her to file a police report.

A check of RPDSS (Pawn Database) revealed an extensive pawn transaction history involving DEFENDANT DANAHOO having conducted 85 individual pawn transactions between 07/03/17 and 11/28/17. During this time frame, DEFENDANT DANAHOO received \$14,385.00 in cash in exchange for the pawned items. On 12/01/17, I proceeded to both Fasset Cash Pawn (Boynton Beach) and Queen of Pawns (West Palm Beach) where I was able to locate 12 pieces of jewelry and 1 laptop computer which had been pawned by DEFENDANT DANAHOO. Investigative holds were placed on the items, they were photographed and sworn written statements were procured from WITNESS pawnbrokers WALTER QUINTERO (Queen of Pawns) and JUAN SALAZAR (Fasset Cash Pawn). The involved original pawn transaction forms bearing the inked thumbprint of DEFENDANT DANAHOO were retained and TOT BBPD Evidence Division to be forwarded to the PBSO Crime Laboratory for latent print analysis.

On 01/05/17, I met with VICTIM KING who subsequently identified all of the photographed pawned items as hers. Additionally she supplied me with appraisal documents for the jewelry items that remain at large. Furthermore after a review of DEFENDANT DANAHOO'S pawn history, VICTIM KING identified additional stolen items which had not yet been reported. Total value of stolen property \$166990.00. Total value of recovered property \$2225.00.

Based upon the above facts, probable cause exists to charge DEFENDANT DANAHOO with 1F count Grand Theft pursuant to F.S.S. 812.014(1)(a)(c), 7F counts Dealing in Stolen Property pursuant to F.S.S. 812.019(1), and 7F counts False Verification of Ownership pursuant to F.S.S. 539.001(8)(a).
