 On the 14 day of October, 2017 at 21:40 (Specifically include facts constituting cause for arrest.)

On 10/14/2017 at approximately 2111 hours, I responded to the area of 25 Van Rd., in the Town of Jupiter, Palm Beach County, FL as a backup officer for MPO Salvemini, who had conducted a traffic stop.

Upon arrival, I observed a white male, later identified as Joseph Donham (w/m; 12/12/1988), standing at the front of MPO Salvemini's marked patrol vehicle. I also observed a black 2010 GMC truck bearing FL tag # Y43SCV stopped in front of MPO Salvemini's patrol vehicle.

I made contact with MPO Salvemini, who advised the following: He observed the aforementioned truck traveling east on Center St. at the light to turn north on S.R. 811 (N Alt A1A). He stated when the light turned green, the truck spun its tires from a stop and quickly accelerated, traveling north, on S.R. 811 at a high rate of speed. MPO Salvemini advised me that he was traveling in excess of 90 MPH in order to catch up to the vehicle and estimated the vehicle's speed to be between 65 and 75 MPH in a posted 45 MPH speed zone. MPO Salvemini further stated that as the vehicle was traveling north on S.R. 811, it was swerving in the roadway. Additionally, MPO Salvemini advised when he activated his overhead emergency lights and siren to attempt a traffic stop on the vehicle, the vehicle was slow to stop. MPO Salvemini stated he attempted to initiate a traffic stop at the intersection of S.R. 811 and E Riverside Dr. The vehicle traveled west on E Riverside Dr. to Van Rd. with MPO Salvemini's patrol vehicle (lights and siren activated), which is approximately 0.3 miles using a GPS, without pulling over. The vehicle stopped in the parking lot at 25 Van Rd. and MPO Salvemini advised when he contacted Donham that he detected the odor of an unknown alcoholic beverage and observed Donham to have bloodshot, glassy eyes. MPO Salvemini also advised that he noted Donham appeared to be disoriented, had slurred speech, and refused to answer where he was coming from (see supplement from MPO Salvemini).

I made contact with Donham, who was talking to other officers on scene. Donham was unable to recall why MPO Salvemini stopped him and did not appear to want to answer questions, as he was giving me very limited information. Donham refused to advise where he was coming from and could not recall when he noticed police lights behind him. While speaking to Donham, I noted his speech was slurred as he spoke.

I asked Donham to walk to the front of my patrol vehicle and he, reluctantly, did. While he was walking, I observed that he appeared to lose his balance, to the left, as he leaned to his left side and walked to the left (towards the rear of my patrol vehicle) before correcting himself and walking to the front of my car.

I asked Donham how his vehicle ended up in this parking lot and he mentioned that he observed lights behind him before pulling into the parking lot. I asked Donham to clarify, due to the fact that previously he was unable to recall any police lights behind him and Donham stated he was unable to recall the encounter and did not provide any additional information.

I asked Donham if he would be willing to complete Standardized Field Sobriety Tasks and he refused. I read Donham Taylor Warnings and again asked if he was willing to complete SFSTs. Donham refused a second time and I placed him under arrest for DUI.

I placed handcuffs on Donham which were checked for proper spacing and double-locked to prevent tightening. I conducted a search incident to arrest of Donham's person and placed him in the rear passenger seat of my patrol vehicle.

I transported Donham to the Palm Beach County Breath Alcohol Testing Facility where I conducted a 20 minute observation period to ensure he did not regurgitate or ingest anything orally. At the conclusion of the observation period, I requested Donham provide a lawful sample of his breath for the purpose of determining the alcohol content and he verbally refused. I read Donham Implied Consent from a prepared text and again requested he provide a breath sample, which he verbally refused a second time. I read Donham his Miranda Warnings from a prepared text, which Donham advised he understood, and attempted to conduct an interview with him. Donham stood silent when I asked him if he was operating a motor vehicle at the time of the traffic stop and I asked Donham if he was refusing. Donham stated he was and I terminated the interview.

I placed Donham in a holding cell while I completed the arrest paperwork. After finishing the arrest paperwork, I transported Donham to the Palm Beach County Jail where he was booked for DUI without incident.

Due to the driving pattern observed by MPO Salvemini (spinning tires, accelerating rapidly, traveling at high rate of speed, slow to stop when ordered by police officer), MPO Salvemini's observations of Donham (disorientation, slurred speech, bloodshot/glassy



If you fail to submit to the test I have requested of you, your privilege to operate a motor vehicle will be suspended for a period of one (1) year for a first refusal, or eighteen (18) months if your privilege has been previously suspended as a result of a refusal to submit to a lawful test of your breath, urine or blood. Additionally, if you refuse to submit to the test I have requested of you and if your driving privilege has been previously suspended for a prior refusal to submit to a lawful test of your breath, urine or blood, you will be committing a misdemeanor. Refusal to submit to the test I have requested of you is admissible into evidence in any criminal proceeding.

## CONSTITUTIONAL WARNINGS


