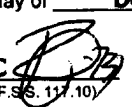

According to Joseph, he and his family were leaving the Panther's Arena after a hockey game in Sunrise, FL. While driving on the Sawgrass Expressway in Sunrise, FL, Amber and Joseph proceeded to get into an argument regarding her vacation to California. While driving in the vehicle, Amber proceeded to punch Joseph in the back of the head. Joseph stated that he then turned onto SW 10th St. to travel to I-95 north. While driving along SW 10th St., Amber punched Joseph in the back of the head again. Joseph reached back to defend himself and calm down Amber, when she bit his finger causing it to bleed. Joseph explained that they arrived at their residence at the address listed above and Amber refused to exit the vehicle. Joseph then walked to the rear of the vehicle, opened the door, and proceeded to grab Amber and lift her out of the car. He stated that Amber was still refusing to get out of the vehicle and was grabbing onto the seats inside to prevent him from pulling her out. Joseph advised that Amber eventually let go of her grip and he sat her on the floor next to the car. I observed Joseph and he did not have any visible injuries to the back of his head and only the bite mark on his finger. BSO was notified of the physical altercation that occurred on SW 10th St., but they did not want to respond due to Joseph not being able to provide an exact address or landmark where they were driving. FHP was also notified regarding the punch on the Sawgrass Expressway, but they did not respond due to the lack of visible injuries.

According to Amber, during the argument, she never touched her father, but did kick the back of his headrest two times. Amber explained that when they arrived home she wanted to sit in the car and her dad told her to get out, but she refused. She stated that Joseph opened the back door and grabbed her by her hips and proceeded to pull her out of the car. She tried to resist him by grabbing ahold of the seats inside of the car. Joseph eventually pulled her out of the car where she was pulled onto the ground. Amber stated that she anticipated the drop from the car to the floor and braced herself with her hands. After she was on the floor, Joseph walked away, and she went inside shortly after. Amber did not sustain any injuries.

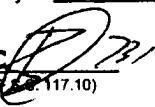
Based on the physical domestic disturbance that occurred in the city of Boca Raton, I arrested Joseph Keller for domestic battery F.S.S. 784.01(1A1), after he pulled Amber out of the vehicle. Amber was provided with a domestic right pamphlet by Ofc. McQuiston and the receipt was turned into BRPD records. Joseph was transported to the BRPD booking facility for processing and ultimately to Palm Beach County Jail.
