	<p>in a car accident earlier and he was mad at her, saying it was her fault. She said they were arguing in the bedroom. Randall said he hit her in the head with his fist. I could see a large contusion on the right side of her forehead. There was also a skin tear, which was bleeding on her left forearm. I asked Randall how that happened. She said he probably grabbed her arm and she has thin skin which tears easily and she bruises easily. She also had bruising on her right shoulder blade, but she was not sure how that happened. Randall said Riechman is her boyfriend of almost 20 years and they live together. She said she is afraid of him and wants him to leave. She said he was in the bedroom in the residence and told us to go inside through the unlocked rear slider. PBFR responded and transported Randall to the Jupiter ER.</p> <p>Ofc. Pope, Ofc. Fandry and I went in the residence. Riechman was in bed, with his eyes closed. We called to him and he sat up. I asked him what happened tonight and he said, "I was sleeping". I asked him what happened between him and Randall and he said the following: She was in a car accident earlier and I was in the car. We were discussing what happened because she was wrong. I asked him how Randall received the injuries (head, arm, shoulder). Riechman said she got hurt in the crash. Ofc. Pope and Ofc. Fandry had been on the crash scene and advised Randall was not injured in the crash and these are new injuries. Riechman then said, she must have fallen because she's drunk. There was blood on the bed (sheets and comforter) and a couple spots on the carpet. Riechman then said, "I didn't abuse her". "We were talking about the crash and she became aggressive towards me". I asked him to explain how she was aggressive and he started blankly and said, "The way women do". I asked again and he stared again and said, "I didn't abuse her". I placed Riechman in handcuffs, which were double locked and checked for proper spacing. He was then placed in the rear seat of my patrol car. During transport to the Jupiter Police Department, he said, "This is bull, she gets away with a DUI and I'm going to jail". "She's a drunk and hits herself and cuts herself". Digital photos were taken of Randall's injuries. Randall completed a written statement and was given a Domestic Violence Packet.</p> <p>Based upon my above described investigation, I find Probable Cause does exist for Joseph C. Riechman for Simple Battery Domestic as he did intentionally touch or strike Susan Randall against her will pursuant to FSS 784.03(1)(a)(1).</p>
