The vehicle than made a wide left turn onto SW 66th Ave and proceed Northbound. As the vehicle was traveling it failed to maintain a single lane of travel and drifted into the bike lane. The vehicle than almost struck several parked cars along the East side of SW 66th Ave.</p>										
	<p>I conducted a traffic stop on the vehicle (bearing Florida tag HRBT19) in the 22000 block of SW 66th ave. Upon making contact with the driver, later identified by Florida DL as, JOSHUA, ADAM, TURNER. I could smell the odor of an alcoholic beverage coming from Joshua. I asked Joshua for his driver license, he was slow to retrieve it and fumbled though his wallet to find it. Upon finding his driver license Joshua had trouble removing it from his wallet. I asked Joshua for the vehicle registration and Joshua produced two of them. One expired in 20017 and one expired on 2018 I asked Joshua for the current one. Joshua gave me the expired even tough the dates were right in front of him. As I spoke with Joshua his speech was slow and slurred. Joshua's eyes were watery and he had a hard time keeping them open. I asked Joshua if he had been any alcohol tonight or been drinking. Joshua advised he had been drinking and stated he had "a drink and some beers" at Coroners. Joshua also advised he had been drink at a bar off Glades Rd earlier in the evening but could not remember the name.</p>

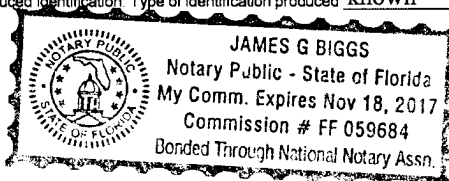



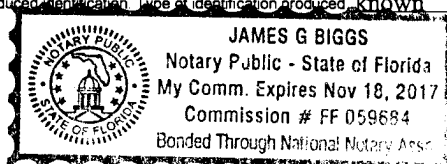
