

On the 20 day of July, 2017 at 01:37 (Specifically include facts constituting cause for arrest.)

On 07-20-17 at 0137 hrs. I responded to a traffic stop at 100 NW 28th St. as a backup officer for Sgt. Smith. Upon my arrival I met with Sgt. Smith who advised me he observed a silver, Hyundai Genesis bearing a Florida temporary tag of BYN6672 driving slowly in the residential area north of Spanish River Blvd. A records check of the expired tag, revealed the vehicle was registered to W/M Gino Setta, residing at 2600 N. Military Trail # 1205 West palm Beach, Florida.

Ofc. Smith made contact with the driver whom was positively identified as B/M juvenile [REDACTED]. I made contact with the right rear passenger, W/M juvenile [REDACTED] and left rear passenger W/M Joshua Kreppel. Both [REDACTED] and Kreppel were also positively identified. In speaking with the above subjects, Sgt. Smith and I were able to detect an odor of marijuana emanating from the interior of the vehicle.

Sgt. Smith and I had all three subjects exit the vehicle where they were separated and placed on the sidewalk sitting down. All three subjects were patted down for narcotics and weapons. A search of [REDACTED] and [REDACTED] revealed negative findings for any narcotics or weapons. Sgt. Smith conducted a search of Kreppel and located (2) large white in color pills which had the numbers 123 on them. These pill were located inside Kreppel's left front pocket. Another small white pill was located inside Kreppel's left front pocket by Sgt. Smith. On one side of this particular pill their were the numbers TL001. In addition, Sgt. Smith conducted a search of the vehicle and located several flakes of suspect marijuana on all four of the the vehicles floorboards.

The flakes of marijuana were field tested utilizing a department issued test kit. The results of the test yielded positive for marijuana. I then contacted Poison Control and spoke with an associate named Michael Hasyn #70690. Hasyn advised me the (2) large white pills were in fact Ibuprofen 800 mg. and the smaller round white pill was methylprednisolone 4mg. Hasyn further

<p>Name (Last, First, Middle) KREPPEL, JOSHUA ETHAN</p> <p>advised both types of pills are not considered controlled substances, however; a prescription is needed for both drugs.</p> <p>Post Miranda, Kreppel, [REDACTED] all advised that an unknown friend had smoked marijuana inside the vehicle earlier today. The above subjects all separately stated that the marijuana located inside the vehicle did not belong to either one of them.</p> <p>Post Miranda, I then spoke with Kreppel and asked him if he had a prescription for the pills or a pill bottle with his name and the name of the medication on it. Kreppel stated he recently had oral surgery and was prescribed these medications by his Oral Surgeon, Dr. Pasqual. It should be noted I was unable to verify this information due to the time of day and the office being closed for the night.</p> <p>Based on the above information, Kreppel was charged with possession of marijuana under 20 grams as per FSS: 893.13 (6b) and with (2) counts of possession of a legend drug without a prescription as per FSS: 499.03 (1).</p> <p>[REDACTED] was charged with possession of marijuana under 20 grams as per FSS: 893.13 (6b) and [REDACTED] was also charged with possession of marijuana under 20 grams as per FSS: 893.13 (6b).</p> <p>[REDACTED] were later released from the PD to their respective parents. Kreppel was transported to the Palm Beach County Jail.</p> <p>The marijuana was weighed at the BRPD and I received a weight of .01 grams.
