On 6/19/17 at approximately 1801 hours I arrived at 600 S Dixie Hwy, Apt 506 ( The Prado ) in reference to criminal mischief.

Upon arrival I met with the victim, Christie Adams who lives at the above location appeared visibly upset and scared. Adams advised she had her friend, Joshua Lewis (W/M DOB 07/30/1990) over at her house because he needed to do laundry. Adams advised that she was getting his clothes out of the dryer when he started to yell at her and "freak" out.

Adams advised that she believes that Lewis might have some kind of a mental condition and appeared to be having a "fit". Adams advised he started yelling very loud at her about things that did not make sense. Adams then stated that Lewis went to her back patio and began yelling outside, and that's when she locked her sliding glass door to keep him out of her residence.

Adams then stated Lewis tried to come back in her residence but when he noticed it was locked he began to yell and yank on the door until he physically broke the sliding glass door lock with his bare hands. Lewis then left the property after he willfully broke the rear sliding glass door.

Due to the above facts and statements I find probable cause to charge Joshua Lewis with (1) count of FSS 806.13(1B2) Criminal Mischief over \$200 under \$1000.
