Please refer to his supplement for further on his involvement in this case. Sgt. Smith made contact with the driver/sole occupant who was identified by Bahamian DL as W/M Joshua Malone. Sgt. Smith advised that he smelled an odor of an alcoholic beverage emanating from Malone's person, his eyes were blood shot, and his speech was slurred. I then arrived on scene to conduct the DUI investigation. I made contact with Malone who was sitting in the driver's seat with the vehicle's engine running. I asked Malone to step out of the vehicle and he had trouble balancing while exiting the vehicle. I smelled an odor of an alcoholic beverage emanating from his person, his eyes were blood shot, and his speech was slurred. Malone stated that he was coming from a party at a friend's house where he consumed six vodka Red bull alcoholic beverages. Malone stated that on a scale from zero being sober to ten being fall on his face drunk that he was a five. Malone advised that he was currently on Jog Rd when in fact he was a couple miles away on Congress Ave. I asked Malone if he would attempt the standardized field sobriety exercises to dispel my alarm that he was driving impaired and he agreed. Malone advised that he did not have any injuries. The first task was the walk and turn. I gave the instructions to Malone and I asked if he understood. Malone advised that he understood, and I then instructed him to begin the task. Malone was swaying during the instructions and unable to maintain in the starting position. Malone failed to keep his feet heel to toe while walking up and down the line. Malone stepped off the line several times. Malone made an improper turn.

The second task was the one leg stand. I gave the instructions to Malone and demonstrated the task. I asked Malone if he had any questions and he advised he did not. Malone was unable to keep his arms at his side. During the exercise he used his arms to maintain his balance. Malone swayed during the task, hopped, and put his foot down several times. Malone put his foot down and stopped doing the task while there was still time remaining in the task. The third task was the English Alphabet from A to Z in a non-rhythmic manner. Malone recited the alphabet in a non-rhythmic manner. The fourth task was the finger to nose. Malone did not close his eyes, tilt his head back, and failed to touch tip of his nose several times. I then placed Malone under arrest for DUI in violation of F.S.S 316.193(1). Officer R. White conducted the observation period and operated the Intoxilyzer 8000. I asked Malone to provide a breath sample and he submitted samples of .231 & .232. Malone was issued a citation by Sgt. Smith for driving the wrong direction and he was TOT CJ. Malone's vehicle was towed by Westway Towing.
